Jim Patmos Tells us About His Hobby of Attending Automobile Auctions

When our scheduled speaker didn't show up, Jim Patmos filled in and told us about his hobby: attending automobile shows and auctions, and collecting cars. Jim noted the area is world famous for its auto shows and auctions.

There are 6-7 of them every year, headed by the Barrett-Jackson show, the Silver show and the Russo-Steele show which he enjoys. There also are several smaller shows that bring in a lot of cars in the \$80,000-\$90,000 range. He has seen cars sell for as much as \$17 million. Most of the shows and auctions are held within a two-week period in January.

Many of these cars have fewer than 200 miles on them, are 60-years-old or older, and have been driven only on and off the truck to transport them to the show. "It is fascinating," he said.

"It's not easy to buy a car," Jim noted. He explained the bidding process and all that is involved. He also told us about car collectors he has met and some of his experiences with them.

The auctioneers go for about an hour or hourand-a-half at a time and have quite a spiel to get the audience going. They have assistants who try to push the bidders to go higher. Total sales range from \$250-\$325 million.
