FOOD VENDORS

LARGE Food Vendors (food trucks requiring a double vendor space): \$400 in advance; \$500 day of show

REGULAR Food Vendors (those requiring a single vendor space): \$200 in advance; \$300 day of show

NON-FOOD VENDORS (car accessories, crafts, artists, etc.)

ALL: \$75 in advance; \$100 day of show

NOTE: ALL vendors, both food and non-food, are strongly encouraged to register in advance, as space is very limited. Space to participate will be guaranteed only for those vendors who register and pay in advance by the *May 17, 2025 deadline.*

Vendor Rules and Regulations:

1. Field access begins at 6:30 am day of show. YOU WILL NOT BE PERMITTED TO ENTER THE FIELD BEFORE THIS TIME.
2. Upon arrival, vendors must check in at the Registration Tent to receive assigned space.
3. Vendors must supply their own garbage receptacles and must empty those receptacles, as needed.
4. Vendor equipment must be removed from the property at the end of the day. Vendor space must be left clean and free of debris.
5. Vendors are responsible for obtaining any necessary permits.
6. **All payments made to Hackettstown Rotary Club Foundation are non-refundable. The Car Show will take place, RAIN OR SHINE.**
7. Vendors will obtain their own insurance, at their expense, for liability and potential loss or damage to their property and goods.
8. Vendors shall indemnify and hold harmless Mars Wrigley. Hackettstown Rotary Club Foundation; it's officers, directors, agents, volunteers, and employees from any and all claims (however and by whomever caused) for damage, injury, theft, fire, water, liability, or loss to any person or property, or by reason of the vendor's participation in the Memorial Motor Madness Car Show.
