

The total contributions received from the District Governors totaled \$632,000. Ron continually emphasized it is not how much was contributed but the fact that 100% contributed to The Rotary Foundation. We were all presented "First Class" buttons which I am proud to wear.

In the same meeting he challenged all of us to take the "First Class" program concept back to our districts. My challenge is to contact all of the 53 Club Presidents in our district and ask each to become a member of the "First Class" of Presidents in our

or more to The Rotary Foundation annually. Members of the Paul Harris Society will be recognized throughout the year at various District events.

Currently we have 476 members in our district contributing on an individual basis to The Rotary Foundation. I would hope that in the next couple of years, we can double this number.

We talk a lot about the process of contributing, the money raised, goals, numbers, percentages, etc. The most important part of The Rotary Foundation is that we are "Changing Lives" one by one both locally and throughout the world. The programs of the Foundation are all done through local Rotary Clubs. Remember in our District last year we received \$180,000 for programs in our district.

The Foundation needs all of our support. I ask that each Rotarian in our District consider supporting The Rotary Foundation this year with an individual contribution.

When it Comes to Membership... Rotarians Mean Business!

So, our emphasis this year is on membership. Let's think for a minute about how business relates to this goal....

She has held the following positions: President-Elect 2012-2013; President 2011-2012; Secretary and President-Elect 2010-2011. She is currently the 2013-2014 President. In addition, Alison is the Public Relations Chair and Co-Chair of Fundraising.

Vocational Service Award

Each year, our district honors a Rotarian from our district who uses their vocation as a means to promote the ideals of Rotary – in other words, someone who truly lives the Rotary motto: Service Above Self.

This Rotarian is nominated by their peers as one who uses the skills and contacts they've developed in the business life and career to help society at no reward for themselves.

Do you know such a person? Is there a member of your club who uses their professional skills and abilities to benefit the community? Someone who gives of themselves above and beyond their "job description" and helps others without thinking "What's in it for me?".

The NJ State Rotary Vocational Assembly will be held on October 7, 2013 at The Pines Manor in Edison, NJ. This is the occasion where Rotarians from all of New Jersey come together to promote Vocational Service as an important aspect of Rotary, and to honor those who have been selected by their Rotarian peers as one who exemplifies the Rotary motto, "Service Above Self".

Do Children Still Need Paperback Dictionaries?

In this day of online dictionaries and smartphone apps, is a paperback dictionary still a necessity? We receive questions like this from time to time from clubs in our district some of whom are unfortunately giving serious thought to stopping a highly satisfying club literacy project for third grade students which some began and have enjoyed for over 10 years.

For some of those who ask the question, the answer could be "no." Some of us are fortunate to have personal computers and handheld devices that give us access to the internet almost everywhere. In fact, it seems so normal that we take it for granted. However, for children who are still learning to read, constant access to the internet is not usually a reality.

According to a recent Child Trends Data Bank report, 77% of children had internet access at home, and 93% of children had access to a computer at home. This does not mean that they had their own personal computer, just that there was one in the home.

Most schools have computers in classrooms or computer labs, but not on every desk. A paperback dictionary, such as we distribute, can be kept in a student's desk or backpack and so is useful anytime and anyplace. The children can mark the words as they look them up and can see how their vocabularies are growing as their dictionaries fill up with chalk marks. There is also the fun of discovering other words on the page when they go to look something up. They can't with a digital dictionary.

Here is a letter from a third grader showing how

helpful her personal dictionary is.

"Thank you for the dictionary. I love it! It's cool. I can use it whenever I want, at home or wherever. It doesn't slow me down like a computer. Now I can use it for doing homework. I can use it at school and not disrupt the class. I can use it for writing and spelling. Thank you.!"

In conclusion, children do need their own dictionaries to be able to develop their writing and reading skills and become resourceful learners. Paperback dictionaries can give all children access to information they need to be successful in school and beyond. Therefore, it is our recommendation, and also of many third grade teachers, that every club continue to participate by ordering as soon as possible the number of dictionaries required to furnish all of the third grade students in your community for the forthcoming academic year. Include name of person to whom dictionaries should be shipped and name and address of the person who is to receive the invoice. Students Dictionaries, which appear to be the most widely distributed dictionary by our Rotary clubs, are now priced @\$2.00. Delivery is 2-3 weeks. Any questions should be directed to any member of the district Dictionary committee listed in the 2013-14 directory.


