This Week: Sally Epstein, Merle Johnson and Lesley Draper will be here to speak to us about 'Impact 100' an organization dedicated to engaging women in philanthropy by collectively providing high impact grants to nonprofits serving the counties of Morris, Passaic, Somerset or Sussex.

Last Week: Bob Morgenstern spoke about the District Ethics Committee. When lawyers commit ethics violations, the committee recommends discipline. The procedure to carry out a complaint is complex; involving contacting the Morristown District 10 secretary, who passes it on to an appointed investigator, who interviews the complainant, then reports to the attorney. The attorney writes a report for the committee, and if warranted, it goes before a judge, where a prosecutor is appointed. Typical violations consist of: using or taking clients' money, lack of client communication, neglect of clients' case, fraud and misrepresentation, conflict of interest, excessive fees, criminal conduct, and disrespect of a judge. A lively discussion ensued.
