Bill Carson, GM Fountaingrove Inn Hospitality in Sonoma County

BILL CARSON believes that he has the best job in the world: He gets paid to eat, drink, and meet a lot of interesting people. As general manager of the Fountaingrove Inn, he keeps watch over a 124-room inn, a 107-seat restaurant, and grounds, and employees he considers to be extended family.

Mr. Carson had a feel for the big picture and knew that the business depended upon a strong tourist trade to keep it going. He became the first chairperson of the Sonoma County Tourism Board after the former Convention & Visitors Bureau closed and is a strong believer in the need to have all the various tourism factions in the county pulling together.

With the help of Doubletree Hotel general manager Bill Comstock and others, Mr. Carson is spearheading efforts to establish a Self Assessment Business Improvement District to raise funds to compete with other major tourist destination regions such

as Monterey and Tahoe.

"The plan is to ask the 500 [larger] hotel property owners in the county if they are willing to put a minimum of 2% of room revenues into a fund designed to give Sonoma the marketing exposure it needs," Mr. Carson says.

This draft proposal will be ready to go out in a few weeks. The current budget for the tourism board is \$1.2 million. But if this initiative is approved, the marketing budget could be increased to \$4 million, giving the county the financial war chest it needs for an effective advertising and public relations campaign.

Meanwhile, Simons & Brecht, which developed the Fountaingrove property, sold it early last month to Angelo Ferro and Bob Miller, who are now acquiring the adjacent Round Barn landmark. Mr. Carson looks forward to adding it to his management portfolio. *From Business Journal —July 7, 2003*

Rotary Scholarship Recipient Jean Irwin



Jean Irwin was raised in Stockton, California. She graduated from Fresno State with her BA in Communicative Disorders in 1978, and a specialist certificate to teach both the deaf and hearing. She began teaching deaf children

using the Signing Method in Vallejo, California in the early 1980's. After a move to Reno, she was asked to develop a program to teach deaf children to speak using the Oral Method where Sign Language is not used. The program was begun with just 2 students, and has developed into a program of 25 with 4 teachers.

Jean continues to work in the Oral Program of the Washoe County School District in Reno , Nevada. She teaches deaf children from ages 6 through 19 by moving from an



middle school and day. All students are mainstreamed into regular classrooms where they are taught along side hearing peers, although they are profoundly deaf.

In 1989 she received a Rotary Foundation Scholarship that allowed her to be part of a deafness research team in Nottingham, England. The skills she picked up in this study have greatly enhanced the education of her students and allowed them to achieve levels of reading that far exceed the average level of 4th grade that deaf students typically reach upon graduation from high school. In Nottingham she learned how to take language from the rich and give it to the poor.

Most recently she has helped lobby a bill through the Nevada Legislature to be sure babies are tested for hearing loss before they leave the hospital.

She is a mother of Katy, 17 and Kent, 12.

SANTA ROSA SUNRISE ROTARY MADE FRIENDS IN JAPAN THIS SUMMER

Welcome home our Exchange Students from Japan! Come and meet our guest speakers, the students and chaperones of the 2003 Santa Rosa-Kagoshima Student Exchange Program (SRKSEP'03). This was the 17th exchange- the 9th time that Sonoma County students visited Japan. SRKSEP is sponsored by our Sunrise Rotary Club, and supported by Friends of Kagoshima under the leadership of Fern Harger.



This year we sent 16 students and 2 chaperones to Kagoshima, Japan. Their tour included Tokyo, Kyoto, Hiroshima and 14 days in scenic Kagoshima where they stayed with a host family. Our club, with Bob Scott as SRKSEP Chairman for the past 9 years, has welcomed 93 Kagoshima students, and has sent 80 Sonoma County students to Japan.



Historical Background: In April, 1865, fifteen young students left Kagoshima, Japan, to travel abroad and learn Western ways. After spending some time being educated in Great Britain and Europe, these students returned to Japan and became the driving force behind Japan's modernization.

One of these students, Kanaye Nagasawa, did not return to Japan and eventually came to Santa Rosa, where he was the builder of the Round Barn and owner of the Fountain Grove Winery. This is the historical link between Kagoshima, Japan and Santa Rosa.

Now, more than fifty years after Naga-

sawa's death, we are sending students to Japan to learn Japanese ways. We hope this cultural exchange will inspire many life long friendships and strengthen the bonds of world peace.




DAN SCHURMAN



September 4th Program

Professor Bill Massey

Addresses the California Recall Election

Bill Massey currently teaches Economics and Political Science at Santa Rosa Junior College. He is the former Chair of the Social Science Department, and is a product of SRJC, San Francisco State University and UC Berkeley.

Mr. Massey will address the issue of California's Recall Election from the perspective of how and why we have gotten to the current state of affairs. He will conclude with an overview of how this might impact all of us as Californians.

Recall Primer—The recall mechanism for statewide officers and legislators in California first appeared as a constitutional amendment in 1911, one of several reform measures put in place by the Progressive administration of Governor Hiram Johnson. Basically, it requires the circulation of recall petitions. Petitions for the recall of statewide officers must be signed by voters equal in number to 12% of the last vote for that office, including voters from each of five counties equal in number to 1% of the last vote for the office in that county. Petitions for the recall of state legislators must equal in number to 20% of the last vote for the office.

The recall ballot has two components: a yes or no vote for recall, and the names of replacement candidates, selected by the nomination process used in regular elections. The recall measure itself is successful if it passes by a majority. In that case, the replacement candidate with a simple plurality of votes wins the office. If the recall measure fails, the replacement candidate votes are ignored.

Recalls have often been attempted in California against statewide officials and legislators. All governors in the last 30 years have faced some level of recall attempt. Significantly, none of the recall attempts aimed at statewide officials has ever reached the voting stage. However, recall efforts against several state legislators have reached the voting stage, and two were actually recalled. These were Paul Horcher and Doris Allen, two Republican Assembly members recalled in 1995. There have been many successful recall attempts at the local government level in California.
