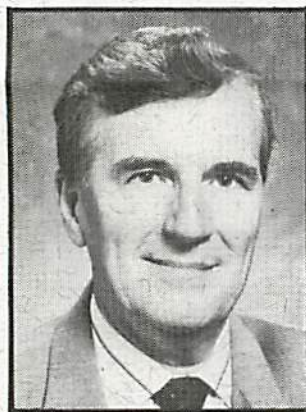

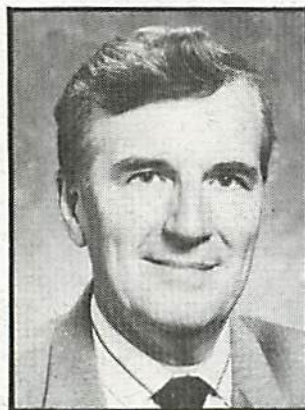

## SANTA ROSA SUNRISE'S ATTENDANCE BY-LAWS

Just a reminder to all our members the following attendance by-laws should be adhered to:

**SECTION 6: ATTENDANCE** All members in good standing in the Club on the day of the regular meeting must be counted as present or absent for at least sixty percent (60%) of the time devoted to the regular meeting at the member's club or at any other Rotary Club attendance as hereinafter provided.

Any member of the Club, not present at the regular meeting, who attends the regular meeting of any other Rotary Club or a provisional Rotary Club on any of the six (6) days immediately preceding the day of absence, on the day absent itself, or any of the six (6) days immediately following the day of absence, shall be given full credit for attendance at his/her club.

Exceptions for any honorary member, a past service member, or a senior active member shall be in accordance with the specifications set forth in the Rotary MANUAL OF PROCEDURE.

**SECTION 7: TERMINATION** The membership of any active, senior active, or past service member, except as otherwise provided in the Rotary International Constitution, (a); who is absent from four (4) consecutive regular meetings, or (b); fails to attend or make up at least 60% of the club's regular meetings in the first or second six (6) months of the fiscal year, or (c); fails to attend at least 30% of the regular meetings of this club in the first or second six (6) months of the fiscal year, shall automatically terminate, unless he/she is excused by the BOARD for good and sufficient reason.

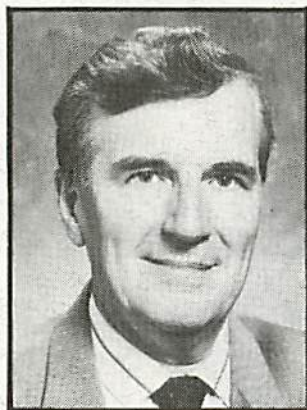
