Jewish Community Free Clinic

The Free Clinic: A volunteer community-based response to the plight of the uninsured amongst us-(our friends, family and coworkers- and how you can help!)

Synopsis: The Free Clinic movement began in the 1960's as a spontaneous, collective response to lack of healthcare access for the poor, in an age of an outpouring of spirited volunteer movements dedicated to bettering the plight of the indigent. As times have changed, so too has the

structure of the now hundreds of free clinics across the country. What has not changed, however, is the dedication to providing free quality medical care, based on voluntarism, to those who would otherwise have little or no access to medical care. This talk will survey the history of the Free Clinic in order to place this phenomenon in context, and will highlight the formation and contribution of several local free clinics including the St. Stephen's Church La Clinica in Sebastopol, the Catholic **Charities Homeless Support**

Services Center Free Clinic in Santa Rosa, the Petaluma Free Clinic and the newest on the scene, the Jewish Community Free Clinic. Discussion of the demographics of the uninsured of Sonoma County will serve as a springboard for a glimpse into how volunteers can begin to address the growing problem of lack of healthcare insurance as it threatens to become a major source of distress in our local community, affecting our friends, family and neighbors.

Bio: Robin Lowitz, M.D. grew up in Berkeley, undergraduate degree in history from UC Berkeley, M.D. from Case Western Reserve University School of Medicine (Cleveland, 1991) and Family Practice Residency, UCSF-San Francisco General Hospital, 1991-1994, Board certified Family Practice physician. National Health Service Corps, Russian River Health Center, Guerneville, community clinic physician, volunteer at several local free clinics. founded non-profit Jewish Community Free Clinic of Sonoma County, October 1991.

Nancy Aita introduced the Save Our Students (SOS) Program and its representatives today, Dr. Mark Doolittle of SSU and two of the school counselors, Emily and Chris. Nancy told us SOS will participate in the Human Race this year to supplement funding. She reminded us the program, now ten years old, was the vision of Rotarian Gordon Lofgren, who formed a Quad Club Committee to partner with City Schools, the Police and the downtown mall merchants to fight truancy problems. As truants were re-

turned to school "it became apparent their truancy was a

symptom of greater problems." This led to the partnership with SSU which placed counselors in schools to assist the students. As it was discovered the kid's dysfunction was related to family dysfunction the Family Education Center was brought on board to assist with parent education, which is now offered in Spanish and English.

Dr. Doolittle gave a brief history, noting the program is 10 years old, and that it began with \$10,000 from Rotary, now has a budget of

\$100,000 mostly from private donation and grants, and has involved 100 counselors. The program is now in 10 schools and at the Child Welfare and Attendance Office.

Counselors Emily Cate and Chris Bloomguard then each shared an example of a student with whom they have worked.

FLOWMASTER 20 Years History and Benchmarks

More than 20 years ago, Flowmaster started in a barn in Kenwood, and today has grown to the \$40M performance aftermarket exhaust leader.

Flowmaster started as a racing only muffler and has crossed over to the performance street market. They crossed over into other markets: the bass fishing market through BassMasters, ties between rock musicians and performance exhaust, Cars for Kids, and our relationship with the top custom car builders in the nation.

Kevin McClelland's background is 100% automotive. Kevin graduated from Los Angles Trade Technology College in 1998, and owned McClelland Automotive from '80 through '84. In 1984, he went into research and development at the Edelbrock Corp. Kevin was in charge of their Emissions lab, Emissions certification projects, and all in-vehicle product testing. In early '88, he moved on to Kaufmann Products, who was one of the leading Ford Performance companies of its time. Kevin was the head of Research and Development, and the Head mechanic of their SCCA Showroom stock racing team.

In late '89, Kevin was one of the founding members of a research and development company call McFarland Inc. He was in charge of all engine development and testing. They also started a relationship with GM as a Performance Parts developer. They developed the GM Performance Part Crate engine program, and built Media cars for GM. In Jan. of '93 McFarland closed and Flow-



master bought its equipment and moved everything including Kevin to Sonoma County.

Today, Kevin is Flowmaster's Dynamometer Operations Manager. He is in charge of all engine related testing and vehicle testing. Kevin also a member of the management team of Flowmaster.

Kevin has competed in NHRA drag racing for over 27 years. Major accomplishments include:

We will have a new piece of equipment with us this time, called an "auto refractor". Patients will look into the equipment, then the auto refractor will determine the needed prescription. Costs per person have yet to be determined and will vary with the # of travelers, but they will likely be no more than the cost of airfare.

PROGRAM RECAP—Jewish Community Free Clinic

Ed Carrette introduced Linda Lowitz who heads up the Jewish Community Free Clinic in Cotati. The clinic is nondenominational and offers medical services at no cost to clients. Linda gave us a history of such clinics dating to the 1960's in Berkeley and San Francisco. There are 400 such clinics in the U.S. founded to address he plight of the unand under insured. She noted these folks are now more than ever "among" us as jobs shrink and the health care system unravels. In Sonoma county up to 23% of the population is unor under insured, including 35% of the Hispanic population and 16% of children.

The clinic relies on donations of time, expertise, money, services, medication and equipment for Drs., hospitals, labs, social services, etc. Some medications are purchased to insure inventory and reliability. Church groups have been primary sponsors of clinics.

The Family Practice Clinic operates on Thursday evenings, and a newly opened Pediatrics Clinic on Tuesday evenings. The next hoped for expansion is a Women's Health Clinic. They have outgrown the space donated to them by the Lion's Club, and have plans to site a modular building donated by SSU in the parking lot of the synagogue across the street

from that location. Permitting and renovations will be costly.

Fundraising is primarily via events and direct solicitation. Grant writing is emerging as very important.

Linda offered that the clinic's mission is in synch with Rotary's values of "service" and "building good will and friendship." The Rotocare program has set up clinics in California, New York and Washington, 1500 Rotarians volunteer in such clinics, and locally Rancho Cotati's Interact Club has assisted the Jewish Community Free Clinic.

Lia Rowley started her professional career working with families and children over 30 years ago and has been in private practice since 1982. As a Behavior Consultant she taught non-violent and positive parenting and teaching approaches to parents, teachers and other professionals.

In addition to teaching she spent most of her time working with individual families in their home setting, working directly with parents and children. It was during these many years of service that

she became more and more aware and concerned about the plight of some of our children and began her dream of a safe place where some children could grow up happily in a safe and nurturing environment, a children's village.

Jacque Gillespie graduated from Law School in 1991. She represents foster youth and has done so for 11 years. Jacque is the mother of five children. Jacque has a strong commitment to community involvement. She is on the Women in Law Board of Directors; Care Counseling Center

Board of Directors; Grandparents Parenting Again Board of Directors and participates in Annual Seminars focused on Grandparents' Rights and Sonoma County Foster Care Forum: She is involved in Routes for Youth: and joined the Children's Village Advisory Board in 1998. She is devoted to Protecting the Best Interests of our Children, and addresses legal issues relating to children and various topics related to teens issues.

It wasn't until the tragic death of Georgia Moses, the twelve year old girl whose nude body was found abandoned along Hwy 101 in Petaluma that Lia Crowley was shocked into reality that something needed to be done, and should be done now. PROGRAM RECAP—Kevin McClelland from Flowmaster

Ray Flugger, President of Flowmaster started the company in a small 800 foot barn in 1983. At that time, they produced mufflers, one at a time. Today, they hold 27 patents and a productive R&D staff develops several hundred car parts. They are best known for their Flowmaster Power Chamber. They have developed a dynometer that attaches to the engine and measures the efficiency of the pressure and fuel. The benefit is that it limits sound and adds fuel efficiency.

Flowmaster has been involved in racing for about 10 years. They produce a special muffler for race cars designed to meet sound requirements-most of these are given away for promotions.

Flowmaster employs about 200 employees in Santa

Rosa and another 200 employees in Sacramento. The ship about 850,000 parts annually; this year they project a 20 percent growth and should ship 1.2 million parts. Their entry level muffler accounts for about 40 percent of their total sales-they will be challenged this November when their patent expires and world competition enters their market. Flowmaster is celebrating their 20th anniversary.



PROGRAM RECAP—The Children's Village

Lea Rowley and Jackie Gillespie told of their vision for an innovative foster care facility. The Children's' Village will be composed of 8 homes each serving 6-8 foster children. They will be 'staffed" by foster parents. There will also be apartments for elders who volunteer to provide grandparenting of the kids, and a community building. This vision is now 5 years old. The group has purchased a piece of property in southwest Santa Rosa and is making concrete plans.

The purpose of this is to address "foster care drift" and to prevent the breakup of siblings, both common occurrences in the current foster care system. 600 kids are currently in foster care in Sonoma County. Of these there are 340 siblings, 76 of whom are not together. 200-300 kids are referred to foster care each year. 47% return home. 40% remain in foster care experiencing 7-8 placement changes during their foster care.

Children who experience this

system are at high risk or a variety of social, personal, academic and health related ills. The Village will reduce these risks and improve outcomes.

The program is based on an Austrian model, which now has three sites in the U.S. The inclusion of elders is an idea borrowed from the Hope Meadow home in Illinois. Ms. Rowley estimates it will cost \$5.5 million to complete the project, with a first phase costing \$2.5 million. They are beginning their capital campaign and seeking volunteers in various capacities.
