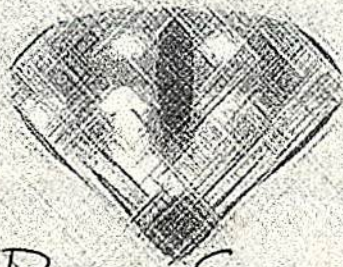

Last June when we were in Haiti doing the Eye Care Project, I had a chance to sit and talk with a young man who was there volunteering at one of our clinics. His name is Antony Denis and it turns out he is an assistant minister in Cayes, one of the towns we visited. He was extremely inquisitive about who we were and he had a hundred questions about the United States and about California. He also wanted to practice his English which was very important to him. He wanted to learn.

Of course I had a hundred questions for him about Haiti and he generously and openly answered them all. Since then we have exchanged some letters. At Christmas time I sent a card and some photographs. Last week I got this letter from Antony. I am including it here in hopes that it will convey some sense of the personal connections that can happen when Rotary does projects in faraway places. Perhaps you can also sense the importance that our contacts have for them.

When we returned, it was easy to talk about the poverty, the filth, and the desparate conditions of the country. It was more difficult to describe the warmth, the caring, the appreciation, the richness, or the character we saw. Haiti is a lot more than what we could report and it is more than we see on the news. Maybe this letter will give at least a hint of something more. Antony's English may be a little goofy, but he can say it pretty well.

Dear Mr. Zumfelde

I am so glad to find this spare time to write you. I hope you'll accept my letter in consideration.

I am so glad also to hear from you for I thought to you so much. When I got the letter and the photos from you, I was found to be delighted. I esteem them like a non-forgetful souvenir or memory in my life. That's why I feel very glad to express my best greetings and my kindest regards to you, to your family and your friends. I am well. I hope you are well alike. May I tell you, everybody in my church interest in sending off their best greetings and their respectful feeling to you and your family.

We would esteem very kindly if you got us a special opportunity to visit our own church and place whenever you would come back to Haiti.

Let me tell you, it is with hardness that we preach the gospel in Les Cayes, for we have economic problems in our zone . . . so we are claiming your prayer. We would adore going on closer at you. I hope to hear from you again to hold our continual connection. I give you some photos like a remembrance. May God's mercy be upon you.

Project Search Committee Report

The following report was submitted by Randy Seelye of the Project Search Committee of the Santa Rosa Sunrise Rotary Club:

The Project Search Committee spent several months looking at agencies, groups and organizations throughout Santa Rosa and Sonoma County trying to find out what is needed. We recommended five projects -- consisting primarily of monetary contributions -- to our Community Service Committee, which they are reviewing and which will probably be considered by the club Board of Directors. The \$3,000 awarded to Rotary's Support Our Students program for their summer counseling in April grew from a recommendation of the project search committee.

Here are projects that the committee considered that include club participation as well as financial assistance. For any of these projects to go ahead, we need to know if members are interested in them -- and interested in helping to make them a reality. If you are interested in any of these projects, please contact members of the Project Search Committee, Community Services Director **Pat Solar** or **Art King**. Committee members were **Lu-Ann Poulsen, Keith Taylor, Merle Hayes, Russ McCracken, Russ Lockner and Randy Seelye**.

Projects requiring a larger club commitment, work parties or proposals that need more study:

1) Becoming Independent

Becoming Independent is a large, well organized social services agency with a budget of more than \$5 million annually. One project where our club might help is in gathering and shipping of handicapped mobilization equipment to Zimbabwe (walkers, wheelchairs). This could be an International Service project, and we might be able to get a Zimbabwe club involved. There might also be a need to repair the donated equipment.

2) Volunteer Center/Western Institute of Science

In a project that could be related to the Becoming Independent idea -- or perhaps even done in conjunction with it -- is a need to coordinate surplus medical equipment from the community and recycle it. The Volunteer Center would produce six volunteers and we would need to coordinate it.

Six volunteers are needed to coordinate renting of space, developing a parts budget and a database or card file to track equipment. Estimated cost is \$1,000 to \$1,500 for start-up costs and a year of renting storage space.

3) Sonoma County Sheriff's Department

Sheriff Jim Piccinini said his department is trying to expand the DARE program (Drug and Alcohol Resistance Education). Presently the sheriff's office operates a program at The Geysers.

This program primarily needs financial support to expand to more schools, but those schools might not be in Santa Rosa. They could be adjacent to Santa Rosa, however. This would primarily be financial support, but could involve club members.

4) The Living Room

A drop-in center for homeless women and children is operated by the Church of Incarnation in Santa Rosa. The is program provides a safe place off the streets and a hot lunch each day. The center needs counters and cabinets (\$1,160 estimate) and storage for children's books and toys. This project could be both a cash and work-party contribution. The church has already donated \$800 to provide 220 wiring to the area.

Our club did construction for the Alzheimer day center at the Church of the Incarnation a number of years ago -- making the area handicapped accessible by re-doing a bathroom and installing concrete over a large area.

5) Open Arms

This organization, as mentioned in the first section, is a new non-profit designed to reduce gang and crime activity among teens. The organization needs \$14,950 in start-up money and supplies, needs board members and all sorts of business experience.

This may be a good project for a partnership of time and money, but we should not get involved until we make sure it's going to take hold. Merle Hayes is meeting with Open Arms directors for additional information.

The 4-Way Test

At the regular club meeting on May 21 Steve Amend accepted a Paul Harris Fellowship Award in the name of his brother-in-law, Robert Sullivan. Robert was Kathleen Amend's brother. The name inscribed on the award is Robert "The Warrior" Sullivan. This nickname was earned by Robert in spite of his 44 year battle with polio. In 1955, when he was 12, Robert contracted polio, four months before the development of the Salk vaccine.

Robert did far more with his life than battle polio. He always worked for other disabled people and indeed for the rights of everyone. In the mid-70's, when he was denied access to his own medical records, he took on the fight of correcting a situation which he could not accept. His work was instrumental in influencing the state legislature and changing the laws that apply to medical records and their access. These laws benefit each of us today.

Earlier this year, Robert died at the age of 56. The contribution of \$1000.00 by Steve and Kathleen, and the Paul Harris Fellowship awarded in Robert's name, is a tribute to him, an acknowledgement of the many contributions of his life, and an acknowledgment of Rotary's ongoing commitment to eradicating polio for all time.

I too had a warrior brother who fought polio for 44 years and I know they are heroes as well as brothers.
