Speaker Recap—The Salvation Army TAM Program

Captain Patty Rasmussen, who has been with the Salvation Army for 20 years and represents 4th & 5th generation family who have been associated with Salvation Army.

Kathy, Office Manager delivered an informative talk on the variety of services offered. Kathy said that in 2003 they had fed, sheltered and clothed 29,000 needy individuals. They offer teen summer camps, youth Bible camps and weekly fellowship meetings for seniors that include field trips and Bible study.

This Chapter's League of Mercy visits nursing homes, prisons and children's homes. They have 2 houses

for newly recovered addicts and offer the 12 Step program to help insure the recovery is long lasting.

Their Emergency Disaster division provides rescue, recovery and mobile kitchens as well as counseling and First Aid.

Their student tutoring program is volunteer based and is currently at 2 schools in Southpark; Burbank and Brookhill, with a 3rd opening in Fremont in September.

Kathy asked for volunteers for this program, which involves 2 hours, one day a week. The first hour is spent one on one with schoolwork and the 2nd hour is spent in recreation, arts, crafts and music.

This tutoring program has been highly effective, witnessed by Brookhill having the highest growth in API scores since the 4-year-old tutoring program has been in place.

It costs our community about \$3,000 each time a kid drops out of school: Court costs, jail time, loss productivity, drug use – all contributing to this figure.

Our Jerry Johnson's North Coast Bank has underwritten this tutoring program, offering employees 2 hours paid time off for their volunteer efforts with the program.

Kathy said their primary goal is small victories, knowing that many small victories result in significant social change.

Poverty and Conditions in Mexico

Eleanore and Jerry Webster and Lynda Burris were part of a group of church leaders and lay people who went to Cuernavaca, Mexico in January. The trip was educational: to inform them about conditions in Cuernavaca and to enlighten them about the work being performed among the poor. The trip was very enlightening. The Sunrise Rotary Club contributed to the work, both in monetary funds to the Sisters of St. Benedict and in medicines, educational supplies and hygiene supplies. They stayed with the Guadalupe Sisters of St. Benedict, at a convent. They studied and went on field trips into the communities.

Lynda Burris shares her thoughts with us, "More than ten years ago, maybe fifteen, Weston Priory in Weston, Vermont, formed a relationship with the Guadalupe Center in Cuernavaca, Mexico, and developed a spiritual retreat program for North Americans to experience the history, culture and economic reality poverty of the indigenous peoples of Mexico. There are groups that attend every month of the year, mostly through church leaders,

across the United States; anyone can go!

"I first heard about the trip about 8 years ago, when a colleague from Vermont moved to Northern California and began leading groups for interested folks in the Bay Area. After my first experience in 2002, I knew I wanted to return, and to invite others to join me in seeing and experiencing life in Mexico in a way that no travel brochure, organized vacation itinerary, would ever offer.

"I will be co-leading another group in 2005, from July 5-14. We stay at a beautiful Benedictine retreat center, where all meals and accommodations are provided. Each group is comprised of different folks - mostly from churches - who want to understand more about our neighbors to the south. It is an eye-opening, life-changing experience."

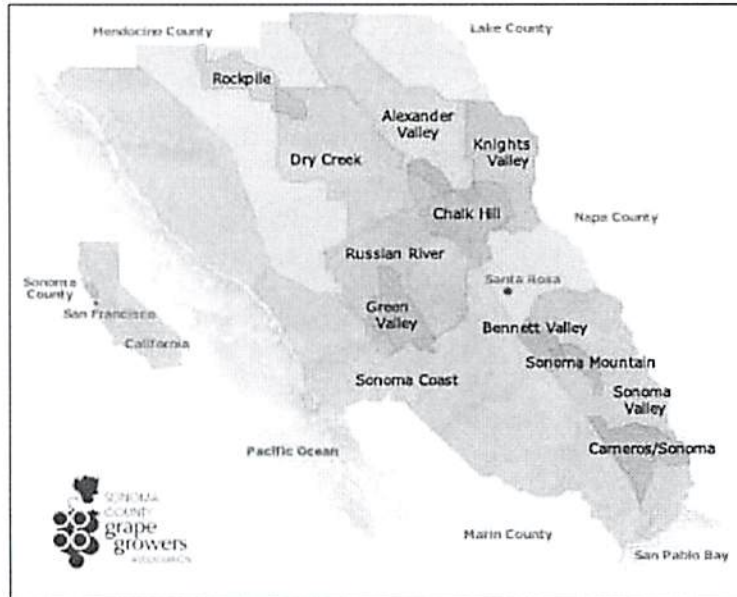

Program Recap—Groups Trip to Mexico

Eleanore and Jerry Webster with Rev. Lynda Burris. VAMOS is a spiritual retreat center for North Americans to experience the history, culture and economic realities of the citizens of Cuernavaca, Mexico. Eleanor, Jerry and Rev. Lynda reported on their tour.

The Benedictine monks and nuns hosted the group giving them room and board, educational classes and tours of the city. These monthly tours earn money to support the schools, which receive no government help. The schools are run entirely by the indigenous people. Here is what they learned: 30% of the population is sub poverty level (meaning they don't have enough to eat). 40% have barely enough to eat and 20% are the middle class pro-

professionals whose numbers are declining. 10% of the population own the wealth of that town and **12 people own 1/3 of Mexico's wealth**. 50% of the people of Cuernavaca are unemployed. Mexico has no unemployment insurance and no social security insurance; therefore 3 – 5 yr-olds are working the street corners selling the artifacts their families have made for subsistence. Government taxes are collected by accountants who figure out what is owed, collect the tax and then supposedly send the tax to the government. There is no subsidized health care. A worker in the U.S. makes \$14 for every \$1 a worker makes in Mexico. Water pipes run above the ground and are stubbed up with a spigot to serve several houses. This is considered running wa-

ter in your house. Often it isn't drinkable. Only 30% of the population own cars and still they have traffic jams. 54% of the people have only 6th grade education and only 19% have more. The houses are built with unsafe construction and electrical practices causing fire hazards everywhere. Every house has a TV because televisions are cheap and electricity is cheap.

Bill and Patty Coleman are the founders of VAMOS. They got the name by combining Vermont (their home) with Mexico where they work. Because of VAMOS 83 schools (all run by the natives) are supported; 35,000 meals per year are served. Many of these students are fatherless because their fathers go to the U.S. and start new lives.

Just Click and Make-up—A new way to “attend” a meeting

Chartered January 2002 as Rotary's first Internet-based club, Rotary eClub One of District 5450 (www.rotaryclubone.org) exists to serve Rotarians with special needs, including those who cannot maintain attendance at regular club meetings because of extensive business commitments and travel, health prob-

lems, or geographical isolation from existing clubs.

Operating as part of the New Models for Rotary Clubs Pilot Project, eClub One has developed policies and procedures intended to maintain the essence of Rotary goals and values while providing online flexibility to its members,

who now number about a dozen, and to the thousands of Rotarians who visit the site to make up missed meetings 24 hours a day, 7 days a week.

The make-up component, which eClub One has designated as its international service project, began in February 2002. To date, more than 8,000 Rotarians have made up meetings by reading one of five informational programs linked to the site and completing a make-up form. The form asks the guest to discuss the information, including how it might relate to his or her home club's activities, and to suggest topics for future make-up programs.

Santa Rosa Sunrise Rotary club make-ups are limited to once, every 60-days. Visit www.rotaryclubone.org.

As a Catalyst for Community Development

Ms. Wang brings an extensive and unique 20-year background in education, arts programming, nonprofit business and law. Prior to joining BAYCAT as a co-founding team member, Ms. Wang was an elementary school teacher in the San Francisco Unified School District (SFUSD) specializing in project-based collaborative teaching methodology that incorporated music, arts and technology into the standard based curriculum. Ms. Wang has been a curriculum developer for the SFUSD, and teacher presenter for the Dean of Education at University of California, Berkeley and for the Bay Area Writing Project specifically on authentic language assessments. Villy currently trains SFUSD administrators, teachers and staff as a consultant. Prior to her nonprofit work, Villy served as the director of

the San Francisco Jazz Festival from 1993 to 1998, where she ran the day-to-day business and operations of this successful nonprofit arts education organization. Through her vision she grew the organization from an annual budget of \$250,000 to over \$2 million. She used this expertise to design and implement jazz education program for elementary and high school students.

Ms. Wang was an associate at Morrison & Foerster, Adjunct Law Professor at New College School and served as a commercial and investment banker in New York prior to moving to San Francisco in 1990.

Ed Flint City of Santa Rosa

Chief Ed Flint was hired on January 20, 2004, as Santa Rosa's 4th Police Chief in 60 years. Chief Flint began his law enforcement career with the California Highway Patrol. After working in Los Angeles and the Bay Area, Ed was hired by the Sacramento County Sheriff's Department where he promoted through the ranks to Captain. Ed served as Assistant Chief of Police for the newly incorporated City of Citrus Heights, commanded the Rio Cosumnes Correctional Center, and the Sheriff's North Patrol Division before being selected as Elk Grove's first Police Chief.

Ed has attended numerous law enforcement schools and has received specialized training in narcotics investigations, SWAT operations, and civil emergency management. He is a graduate of the FBI National Academy and the POST Command College. He holds a Bachelor of Science Degree from California State University, Sacramento, and is completing his graduate studies at California State University, Long Beach. Ed holds a community college teaching credential and taught at the Sacramento County Sheriff's Training Academy on a variety of topics.

Ed made significant contributions to several important endeavors for the Sacramento County Sheriff's Department, such as the creation of the Sheriff's Narcotics/Gangs Division, implementation of community policing and stationhouse management concepts, and the startup of the Citrus Heights and Elk Grove Police Departments. Ed received numerous letters of appreciation, awarded five Sheriff's Unit Citations for outstanding performance, and received the Sheriff's "Manager of the Year" award for 2001.

In addition to his law enforcement career, Ed is a Colonel in the United States Army Reserves and is branch qualified as an Infantry and Military Police Officer. He was the Group Commander of SEG3, 1st Brigade (BCST), 91st Division (TS) at Camp Parks in Dublin, California. Ed is a graduate of the U.S. Army Command and General Staff College and was selected for the U.S. Army War College. He was transferred to the Inactive Ready Reserve (IRR) on January 1, 2004, following an eight month deployment in support of operation enduring freedom.

Ed now lives in Santa Rosa with his wife Karen of 25 years. They have two daughters, Natalie and Tiffany, both engineering students at Cal Poly San Luis Obispo, California.
