The following is a proposed amendment to ARTICLE IX of the by-laws of The Rotary Club of Santa Rosa Sunrise.

(Changes noted in underlined italic)

Upon written application to the Board of Directors, describing a specific medical or health related condition including the duration of the requested absence from meetings, a leave of absence may be granted excusing a member from attending the meetings of the club for a specific length of time.

If a member has a temporary, non-medical situation which would prevent them from regular attendance of club meetings, the member may request a special leave of absence by making a written application which shall be presented by the member in person at a regularly scheduled board meeting. Under such circumstances, the member may be granted a special leave of absence for a pre-set length of time, but would be expected to participate in the ongoing functions of the club (i.e. work parties, committee assignments).

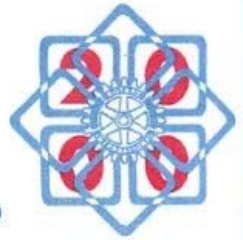
