The Brother Jonathan—During a summer storm in



1865, the Brother Jonathan struck an uncharted rock trying to make safe harbor at Crescent City. Of the 244 people on board, only 19 survived. Most of the ship's cargo of gold, camels, china, and other items sank with the ship in water over 250 feet deep. More than a century passed before the wreck was finally located.

"We don't know how to fight this war yet, but we are going to learn" was his message to us all regarding the war on terrorism.

The special event was the brainchild of Santa Rosa East Past President Bob Blanchard, intended to be a thank you to veterans, rather than a fund raiser or political statement. "We are starting to lose our World War II veterans, so we wanted to say, 'Hey guys, thank you for a job well done,' "he said.


