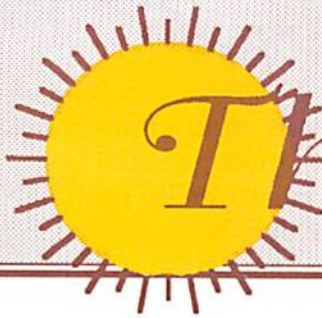

## GREETINGS FROM EVE

### A.K.A. "AWA"

*This is a continuing article from last week's issue...*

Most of the Crossroads groups have about ten participants. My groups started out with 11, but several dropped before we even were to meet in New York and we ended up with only six persons total—all female, unfortunately. French is the official language of Senegal, but the indigenous Wolof language is more commonly spoken in the villages, as is Pulaar and Arabic. We were given Wolof names by our host, Makhona Mbaye, and quickly learned enough of the language to greet people. This is very important as one must shake hands repeatedly throughout the day—except, of course, with the Moor men—they see women as "unclean" so they won't offer their hands when greeted. My Wolof name is Awa (Wolof for Eve) Mbaye named for Makhona's aunt. All of the ladies in the group had Woldof names and a namesake in the village which instantly gave them a bond with a local family—Makhona's intention to be sure. Regardless of our names, we are all "toobahbs" or foreigners and children would typically shout "toobahbs! toobahbs!" when they'd see us.

The village of Kuer Momar Sarr is a regional hub located on the largest lake in Senagal. It has a weekly market that offers everything from fish to fabric, and the full range of odors that come with them. Of course, all prices are negotiable, but regardless—toobahbs usually pay a higher price than the Senegalese. It is an adventure just to buy a pair flip flops. Unlike most Crossroaders, we had a cooks, Endura and Rochaielle, who did all the food marketing and preparation so we did not have to budget, buy, and prepare our meals. The standard meal for us was "cheb oo jen", which is fish and rice, served in a large communal plate which we ate from often sitting on the ground and sometimes using our hands rather than utensils. Most local folks ate more rice than fish. The village acquired electricity last December and already there are 11 refrigerators in town. Most Crossroaders don't get chilled water, cantaloupe, watermelon and mangos. I was not successful in getting my group members to appreciate how comfortable we were to other Crossroads groups. We slept three per room in cement houses with lights, fans, and purified water that tasted even better than the bottled water in the capital city of Dakar.

As it feels like I'm hogging space in the bulletin, I'll continue next week with a description of our work projects.

Mike has been in lots of Santa Rosa schools as a student, teacher and administrator. Now at Elsie Allen high school, Mike feels he has found the perfect position. Mike isn't new to Rotary—he changed clubs from a lunch to the wonderful breakfast. Not for the food but the meeting times.

Rolf introduced the speaker, Becky Lunders, from the American Cancer Society. It's the largest volunteer organization in the country. By raising funds, the fight against cancer is winning. Four major areas are funded. One research: about 40% of hospitals and

labs have produced 28 Nobel prize winners in their quest. Second, Prevention—the stop smoking drive has been very successful which accounts for about 66% of the cancers. Diets that the Cancer Society recommends are healthy. The third area is Early Detection—it's not the kind of check ups you'd like to have done but they need to be done. The earliest detection is the easiest to cure. The fourth area is Education to teach what to look for and traits in familiar provide the earliest detection. Incidentally, 1,600 men will be diagnosed with breast cancer this year.

One of the biggest growing fund raising is the Relay For Life. This year for Santa Rosa is October 10th—11th at Cardinal Newman high school. Well Gary Bayess jumped at being a team captain and Eve Nighswonger is to help so if you also want to help fight cancer, raise money and learn some—let them know.

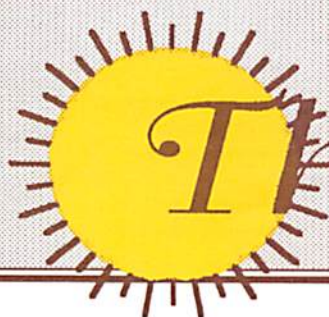

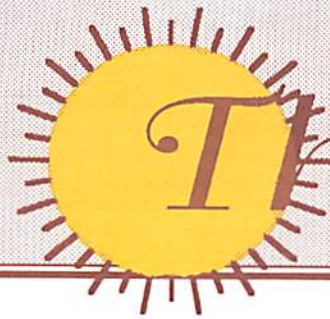
