HOW DOES A CORPORATION JOIN ROTARY?

Corporate memberships are reputable and established businesses, corporations or organizations located in or near Boswell. Corporate members may appoint up to four designees, one of whom should be a member of the business's executive team.

WHO IS A MEMBER OF BOSWELL ROTARY?

One designee shall be considered primary who shall be listed as the member of Boswell Rotary. Additional designees may be listed as official members of Boswell Rotary; the regular membership dues fees would apply for each (not considered "associate members").

ASSOCIATE MEMBERS

Up to three (3) persons will be considered "associate" members (not listed as an official member of Boswell Rotary).

WHO QUALIFIES TO JOIN ROTARY?

Designees are adult persons of good character and good business, professional and/or community reputation, who are engaged as employees of the Corporate member.

WHO CAN VOTE AND HOLD OFFICE?

All designees except "associate" members shall have a vote and will be eligible to hold office in Boswell Rotary or be a director of the club.

WHERE DO WE MEET?

We meet at The Farmer's Table on Thursdays from 6:00 – 7:30 pm.

Starting January 2015, we will meet on a flexible schedule as follows.

- First Thursday of the month: 6:30 – 7:30 am
- Second Thursday of the month: 6:00 – 7:30 pm
- Third Thursday of the month: 6:00 – 7:30 pm
- Fourth Thursday of the month: 6:00 – 7:30 pm

Occasionally, we will meet at another location or cancel a meeting. Announcements may be made via phone, text, facebook and/or email.

HOW MUCH ARE DUES?

Dues cover only the cost of dues and fees associated with Rotary International (RI) and Rotary District 6540. Corporate member dues are \$75 paid semi-annually. Additional dues of \$60 paid semi-annually applies for each additional designee listed as an official member of Boswell Rotary. The corporate member is responsible for the dues. The dues will be prorated (by quarter).

MEALS

The meals are provided by The Farmer's Table. Including tip, the meal costs \$8. Each designee is responsible for the cost of the meal where applicable. This is paid weekly before the meeting. To add or cancel a meal, please call Linda Gibson at 869-4218.

OTHER FINANCIAL OBLIGATIONS

Rotarians may wish to donate money in the form of a 50/50 drawing or by "spinning the wheel". Costs range from \$0 to \$2.

Rotarians are asked to make The Rotary Foundation one of their charities of choice.

ATTENDANCE REQUIREMENTS

To remain in good standing, Rotarians are asked to attend 50% of a combination of club meetings, board meetings, committee meetings, District 6540 meetings and/or service projects. Additionally, you can “make up” a meeting online or at an area club meeting/project such as Fowler or Otterbein Rotary clubs or Benton Central Interact club. The corporate member can ‘share’ this requirement among all designees.

WHAT IS THE NEW MEMBERSHIP PROCESS?

Your sponsor will ask that you complete the membership application. The application will be submitted to Boswell Rotary board and club membership for consideration. As soon as your schedule allows, you will be inducted into the club.
