Process for Proposing a New Member

Rotary is by invitation only, following a defined process. The sponsoring member should complete the new member application (available on the club website) and submit the application back to the Membership Chair for processing. Candidates will be reviewed to assure qualifications and classification. The candidate will be presented for membership approval to the Board of Directors. Upon Board approval, the candidate will be published to the membership for review and comment. Following a 10 day publication period, provided there are no written objections; the candidate will be invited to an orientation and be invoiced for their club dues. The sponsoring member will notify the applicant of their membership approval.
