Attend one Allen Sunrise Board meeting within your first three (3) months to observe internal Club operations

Actively participate in one Club service project that make lasting change in the City of Allen

Actively participate in two (2) of your assigned Flag Team's deployments under the Club's Flag Lease program

Attend one District 5810-lead Roundtable in the first 60 days during your first Red Badger period

Attend one Club Social within your first 3 months of membership
