The Greenville Rotary Club will award up to two \$2,000 to qualified recipients. The \$2,000 scholarship will be paid directly to the university or college of the recipient's choice.

Eligibility: Students must be any high school senior with a permanent residence within Hunt County (this includes any senior who attends ANY school within these districts). Financial need will be considered but is not the sole determination for award. Students must have maintained a grade average equal to a "B" or above, and must be a direct descendant - i.e. child, grandchild, great-grandchild, etc. - or a legally adopted child of a wartime U.S. military veteran who served on active duty during at least one of the periods of war listed below:

- World War I Apr. 6, 1917 Nov. 11, 1918
- World War II Dec. 7, 1941 Dec. 31, 1946
- Korean War June 25, 1950 Jan. 31, 1955
- Vietnam War Feb. 28, 1961 May 7, 1975
- Lebanon/Grenada Aug. 24, 1982 Jul. 31, 1984
- Panama Dec. 20, 1989 Jan. 31, 1990
- Persian Gulf War Aug. 2, 1990 Until cessation of hostilities
 Includes Operations Enduring Freedom, Iraqi Freedom, & War on Terrorism

Applicants who are Gold Star direct descendants will receive 5 bonus points.

Applicants who are direct descendants of current Greenville Rotary Club members will also receive 5 bonus points.

- Form DD1300 (Official military death certificate)
- Official record of burial in a military cemetery issued by the National Cemetery Administration of the Department of Veterans Affairs

UNACCEPTABLE

- Any otherwise "acceptable" document that is illegible
- Obituaries
- Pictures of military headstones
- Pictures of servicemembers in uniform
- Entries in non-military and/or non-official records or books
- Membership cards from veterans organizations
- VA Healthcare Cards

The following locations may be of assistance.

- Many certificates of discharge prior to 1979 do not appear to be "official" documents as many were typed onto a sheet of paper. If you are unsure if it is an official document, please call Bob Jordan at 903-450-3205 to help you.

- The County Clerk and Recorders Office where the veteran resided.
- The funeral home may have kept a copy if military honors were provided.
- Monument company if VA headstone or marker was ordered.
- If the veteran had utilized a VA Home Loan there may be a copy of the DD214 with the title documentation.
- Veterans who have signed up for EBENEFITS through the Veterans Administration may be able to obtain a printable copy from https://www.ebenefits.va.gov/ebenefits-portal/ebenefits.portal
- The State Director of Veterans Affairs may have received a copy of the veteran's DD214 at the time of discharge from military service. This will be specific to the state in which the veteran home of record.
