**F**ORTY ONE guests and visiting Rotarians descended upon us for the political theater of our PISD Board of Trustee Candidate Forum. Members outnumbered guests only two to one. One hopes we all put in an effective pitch for joining our Club! **Sainted Editor** wanted **PRESIDENT LAMPLIGHTER** to announce that our programs run the gamut from the Mayor's State of the City to a Treatise on Lion Mating Rituals, but he demurred. (So much for **Sainted Editor's** foray in PR.)



**LENNY** cautioned all the electioneering candidates to stand by their tables and began the ritual at 12:15, calling upon **Ean Sullivan** for the Invocation and **LARRY FLANNERY** for the Pledge. (*Scary Bob* was *sotto voce* today.) **LENNY** credited **Jamee Jolly** with Greeting and announced that, such was the turnout, we would forgo the usual guest and visitor introductions.
