commitment" to District 5810. (But, to my knowledge, Bud's never been committed or however briefly institutionalized.)



DG Bud took the podium and, recognizing the average age of the Geriatric Rotary Club of Plano, recommended that those in the back turn up their hearing aids. There was delayed laughter as we explained the joke to the hard-ofhearing.

Bud told of being invited to a Club where an important chef asked him what kind of pie he most liked. Of the three choices, Bud chose the Coconut Cream Pie. When he arrived at the meeting, the place was packed: standing room only. His ego swelled at the thought that so <u>many</u> had turned out to hear his address, but that hope was dashed by a participant who said, "*No, we're only here for the pie.*"

His day job was once in the Aerospace Industry where he was assigned the organization of major projects. He said that he tackled them first by gathering together a team of experts in the fields necessary for the project. And with 35 years of team building under his belt, he had his share of "*Mission Success.*"

But that was organizing employees. Organizing volunteers is another kettle of fish, or, considering that it's Rotary, another herd of cats. They are an independent breed, but many can be found that *"have the passion to"*

serve" the District. So it was that Bud was able to fill out his organization chart.



He said that 2011-12 will be a challenge for him and the other **534** District Governors around the world. They'll be herding **1.2 million** members under the mantra of

When Bud went to District Governors' Elect Preschool, he was to hear from President Kalyan Banerjee, who conceived the mantra. From the name, Bud concluded that he was Indian, perhaps Hindu. He told us that Rotary, concerned at the wizened state of its membership, has added *New Generations*, a fifth Avenue of Service encompassing **RYLA**, **Interact**, **Rotaract**, and **Student Exchanges** to emphasize the need to capture the imagination of the young. After all, there needs to be someone to whom our baton is passed when we are likewise. So Bud is emphasizing PR to raise public awareness of the fine work of Rotary

- **1.** Adoption Awareness Carnival at the latest of which 11 children were adopted,
- **2. Tuberculosis** management, because the disease is staging a comeback,
- 3. Angel Tree,
- 4. Various **fellowships** from wine circles on the one extreme to motorcycle clubs (!) on the other,
- 5. Blood Drives, a favorite of DG Aide-de-Camp CEORCE ELKING, and for which 5810 is renown in RI as the VAMPIRE District,
- 6. Water projects both domestic and in Africa,
- **7. Operation Veterans' Support**, manifested in the building of a second Fisher House for the families of rehabilitating or wounded veterans,
- **8.** Wheelchairs because of the tears of gratitude in the eyes of recipients, and
- **9. Rotary Emergency Disaster Initiative** (REDI) that acts as *"second responders,"* recently in Louisiana.

He spoke of his treks to New Orleans to help "*muck out*" or tear down ruined dwellings. He mentioned a local lawyer (not by name) who showed up on one such outing. He was handed a crowbar, pick, and hammer, and had to have all three explained



to him, after which he was directed to an address to tear out the walls.

Some time later, an elderly Cajun couple accosted Bud with what he first thought were words of gratitude, but he soon discovered they were not. The lawyer had gone to the wrong home.

Bud's sister was afflicted with bulbar**polio**andhad"*beenpronounced* dead twice on the way to the hospital." She survived and has miraculously recovered the full use of her body except for difficulty swallowing. Bud remembers massaging her limbs to maintain their circulation, and it has left him with a deep, personal commitment to the eradication of the disease, matching Rotary's. He is pledged to its elimination in his year and is encouraged in that by 2010 having seen but a single case of polio in the massive population of India.
