With JOEFF's announcement of a mini-Board Meeting (is that like the Small Council in KING'S LANDING?) after our luncheon meeting, he summoned Program Chair Joe Camarena to introduce the speaker.

Shelia James is the Program Director for the wellness center for older adults located at the Senior Center in Plano. She earned a Bachelor of Social Work degree from the *University of Mississippi*, and, for the past 10 years, she has coordinated services for seniors and people with disabilities. Shelia is originally from Mississippi, where she spent four years working with the Area Agency on Aging under the Medicaid Waiver Program. Shelia's hobbies include working out and watching football and basketball. She enjoys being a servant to others, connecting people to appropriate services, and helping to improve their quality of life. (shelia.james@wellctr.org)

Shelia apologized proactively for her charming, country, southern drawl. Even her children have commented, "You talk different!" just before losing dessert. The Ole Miss in her caused a spontaneous, "Hottie Tottie," which was answered by "Gosh Almighty" from a fellow alum.

Settling down to business, Shelia told us of her social work with *Head Start, Child Protective Services*, and for the Senior Homeless. She's been 12 years in Plano, where her son has just graduated from *Plano West* with a **3.7** GPA and is seeking a Football Scholarship to college.

She offers emotional support and counsels senior caregivers. They hold Support Group Meetings every 2nd Wednesday for dementia patients and their caregivers.

Shelia worked for the Dallas Housing Authority for a decade prior to her current position, which she's occupied for only 10 months. So we were to give her a pass if she wasn't yet up to speed, but then how were we to tell? She confessed nervousness, but we took everything she said as gospel. You go, girl!

Her office offers transportation services to get seniors to their hospital or doctor visits. Shelia confessed that's her favorite program. She told of a client with 3 rounds of breast cancer that was cared for by wellness center volunteers. And she put in a plug for more volunteers.

But the Center has other services like wound care, blood pressure screening, diabetes education, and even toenail clipping, although the latter comes at a \$15 charge.

Two social workers are on staff for counseling. A part of their day is spent tutoring senior clients in the intricacies of Medicare!



Shelia is in charge of the Gatekeeper and Transportation Programs aiding at-risk seniors in both Plano and McKinney. The latter is only for part of the city that lies in area code 75069: east of 75 roughly between Stacy Road and University...the Fairview area. Through a coalition of six agencies (wellness center for older adults, **MCKINNEY ROOTS**, LIFEPATH SYSTEMS, HOPE CLINIC, community lifeline center, and COMMUNITY HEALTH CLINIC), the **BE-YOND BLUE** program fights depression, isolation, and food insecurity among 75069's senior population. Clients should be referred to (972) 542-0020 ext. 104 for access.



With all that help, there's still a "desperate" need for more volunteers to transport (on their own nickel) clients to community events and to see family members. So, presumably, one can contact the same number to volunteer.

JOEFF asked whether the transport was from door-todoor and was told, no, it is from the Senior Center-to-door. Shelia asked that we refer potential clients to her office.

John Priest asked about paid staff. Shelia told him that there are seven paid staff members in her nonprofit, two nurses, two social workers, two clinicians, and one office manager (herself). Funding comes from City of Plano grants and, of course, donations.

Maria Mott asked if the State of Texas provided funds, and Shelia confirmed that.

Randy Langford, Executive Director of Life Care, said that the Wellness Center is "a wonderful ministry" to whom he has directed "a gazillion seniors."

John Caldwell reinforced the notion of social isolation saying, "You gotta have people to talk to."

BEYOND BLUE also transports folk to social events at the Center like the Tuesday Game Day in McKinney.

Janis Allman touted the lunches at the Senior Center, apparently from personal experience. John Caldwell asked if reservations were necessary for lunch and was told, no, he's free to show up and chow down at the Gazebo Café.

Kelly Palmer asked if the Center received donations of used equipment and was invited to so provide.

Joe Camarena noted the **BEYOND BLUE** brochures on the tables. Shelia thanked us for inviting her and received thanks in return and a multiport charger from

IDEFF, who told her, "Keep up the good work!" Then he issued "a late nomination" for President-Elect in place of **Roy Reeves**, who had "shirked his duties." JOEFF nominated Joe Camarena with the caveat that he must attend PETS, President-Elect Training Seminar, at 5810. In the discussion following his seconding, it was noted by Kelly Palmer that Joe's qualifications were that he had won the Ugly Sweater Contest.

Stumping for the post, Joe told us that, although he had just received his two-year attendance pin, he has been a Rotarian since the 80s. Indeed, Plano Rotary is his fourth club, and he has served "a lot of positions" in previous clubs. Surely on the strength of this stump speech, he as elected by acclamation.

Nancy Humphrey announced the MLK program at Williams High School that evening at 6:30. (Williams is located at 1717 17th Street.) She also touted the Hendrick Scholarship event at Classic BMW on 27 February.
