Earnest had supplied cheat sheets. He told us of an epiphany he experienced, dreaming about MLK, Jr. It concerned the introduction of a young man to the charismatic Reverend at a rally in Birmingham, AL.



The young man, we'll call him "Ricky," lived with his family, including his younger brother, Aubrey, in a suburb called Eureka, pronounced "*Uricka*" by its inhabitants. So he was *Ricky of Uricka*.

Ricky was the consummate baseball player; his team won almost all their games. He played in a field out behind his house. And his ears were well-tuned to the voice of his Mother, calling from the back-door. He knew he had to come when called or there would be "*consequences*."

He was usually called just before dinner, but on the day in question, he heard his Mother's voice well before the appointed hour saying, "*Ricky, come home! We're going to a rally.*"

Inexplicably, he had to take a bath and dress in his Sunday best for the walk to the bus line 1/2 a block away.

"Momma, why we goin' to this rally?"

"We're goin' to hear Dr. King," she replied.

"OK," he said, oblivious to its import.

In 20 minutes they were in downtown Birmingham and moving toward a park overflowing with more people than Ricky had ever seen (at baseball or football games). Someone introduced MLK who then spoke to the crowd. Even at that young age, Ricky was taken aback by the power in the Reverend's voice. His subject was Segregation. But soon another voice was heard from the crowd shouting, "*They have us surrounded!*"

There followed panic and screaming as police, German Shepherds, and firemen (with hoses set to the level required "*to strip bark from trees*") moved in on the rally. The audience ran and was met with released dogs and fire hoses at the periphery of the park.

The family ran with Ricky in charge of holding onto Aubrey as they escaped the mayhem. But Aubrey was torn away from Ricky's grasp, and the noise was so great that the Mother couldn't hear Ricky's plea, "*Mom, stop! I've lost my brother!*"

When at last they reached a place of shelter, she finally heard him and chastised him as they turned back into the fray. When they reached 6th Avenue and 16th Street (University of Alabama campus), Ricky's ears picked up another familiar voice, that of Aubrey, calling his name. There he was, on the shoulders of a stranger, being carried to safety.



Relief, joy, fulfillment cascaded through Ricky, who hugged the leg of the white man bearing Aubrey to the safety of his Mother. He never got the man's name, but he learned that day that some people have good character regardless of the color of their skin.

Later, he asked his Mother why there was such obvious anger in the members of the police, and she replied, "*I will ask you to pray for them, for they know not what they do.*"

Far from apocryphal, the story was intimately known to Earnest who confessed to being the youngster who lost his brother on that day. He fleshed out more of the times and environs by mentioning that, although the nearest high school was only two blocks away, "Ricky" was obliged by segregation to attend an all-Colored one four miles distant.



Martin Luther King, Jr., was arrested in the spring of 1963, and spent his incarcerated time writing "*Letters from the Birmingham Jail*" in support of an activist Civil Rights Movement. There were "*many controversial events in MLK's life,*" but "*the Reality of what he did was obvious.*" He unified a community under a common cause. (And he changed the discrimination laws in the City of Birmingham, which now sports a *Martin Luther King Drive*.)

Earnest detailed Plano's MLK activities for us.

- **Monday 1/18** a *Power Leadership Breakfast* (Sen. Shapiro in attendance) will be held at *Collin College's* Spring Creek campus at 7:30 am, and
- **Thursday 1/21** there will be a tribute to MLK by *Plano Independent School District* at the *Plano Centre*.

Earnest was surprised when there were no questions, but Randy explained it, "You tell a good story!" John Ernst, saying, "We support everything you do," offered Earnest Rotary's check for \$1,000 for the *Unity Walk* and scholarships.
