She mentioned that there would be a reprise of the communal toolbox thing whereby we all bring a new, useful tool to add to the auction item. And she reminded us of our oath to participate in Club activities taken when we were inducted. It's just a *little* heavy-handed, Lori.

Brad added that if we were between significant others, we might bring "insignificant others," which, he maintained, "helps John." That isn't a **little** heavy-handed, Brad!

Perfect Attendance pins went to **Nancy Humphrey** (1), **Jessica Jackson** (7),



and **SKIP JENKINS** (16). **Brad** also noted a birthday check from **Earnest Burke** "for an undisclosed amount."



Citing his having "*batted .500*," **Brad** called for Chuck Morgan to introduce the day's actual program. Ascending the podium, Chuck told us that we'd hear about **MEALS**ON**WHEELS** 

from the Chairman of its parent organization, **Mark Heidenheimer** (whose name means "one who has a home on the heath" in German) of the COLLIN COUNTY **Committee on Aging**.

Mark allowed as how his organization has a quasi-governmental sound to it, but, fearful of any potential Tea Party activists among us, he hastened to point out that it is <u>really</u> a 501 (c) (3) charity that draws **most** of its funding from private resources. (That wouldn't satisfy **Grover** 

**Norquist** who has persuaded 234 of the 240 House and 40 of the 47 Senate Republicans to sign his "No Tax" Pledge. Sainted Control predicts the remaining 13 moderates can't be re-elected in the current political climate. TIME reports that *no* Congressional Republican has voted for a revenue increase for **20 years**!)

He asked us for a show of hands of all who knew, before today, of the existence of the COLLIN COUNTY **Committee on Aging**, and a few hands went up. "Cary's heard of everything," he remarked as **Cary Israel's** hand rose. "My daughter worked with **MEALSONWHEELS**,"



Cary explained. Then Mark asked for those who knew of **MEALS**ON**WHEELS**, and got the majority of the Club.

He explained that both organizations fight hunger and isolation in a vulnerable portion of the community. Indigence isn't a necessary qualification; the inability to fix meals or travel to them suffices.

Collin County is experiencing a Senior Explosion that has less to do with spontaneous combustion than it does a generally aging society. And Collin is the sixth fastest growing county is Texas. Both facts conspire to make

### **MEALSONWHEELS** a growth industry.

It needs only two things:

- 1. To hear about potentially needy clients, and
- 2. To *raise* funds!

**MOW** needs private funding because the government pays less than the cost of the meals. (AHA! Feeding at the public trough after all, eh, Mark? For shame! How do you live with such sin?) And with that, Mark introduced the aptly-named **Lara Kitchens**, Volunteer Coordinator for **MOW**, and he retired to serve as Laura's *PowerPoint*<sup>™</sup> manager.



Lara wasted no time touting her charity's good works. **MOW** not only provides for the food welfare of Collin County elderly but for their transportation needs as well. Funding from both Federal and State departments of Aging goes to the 1,965 local **MOW** programs.

The remainder of their resources comes from cities in the County, private organizations, the United Way, and individual donors.

Qualification for clients include

- 1. Age 60 and up or
- 2. Disabled and
- 3. With limited ability to shop or prepare meals,
- 4. No provider in the home, and
- 5. Homebound or with limited ability to transport.
- Clients are referred to **MOW** by
  - 1. Self, family, friends, neighbors, hospitals, and rehab facilities.
  - 2. A Home Delivery Meal Coordinator assesses the potential client and
  - 3. Determines eligibility.

**MOW** has a Durable Medical Equipment program that distributes donated walkers, wheelchairs, bath benches, etc. Under Kitchen('s) Facts were an annual use of

- 100,000 cartons of milk,
- 140,000 desserts,
- 25,000 servings of cornbread,
- 1.3 tons of salad mixings, and
- 12,000 servings of salad dressing.

The luncheon meals provide 1/3 of the daily nutrition requirements. Each and every one of the 160,000 annual meals is a diabetic meal regardless of clients' medical status. **MOW** also provides health literature to its clients. While some clients qualify only temporarily following surgery, for example, the vast majority is qualified indefinitely.

Most of the 600 daily meals are lunches, but, if the cities kick in funding, **MOW** can provide evening and weekend meals. They also provide for the four Collin County Senior Centers. No one is required to pay, but a donation of \$5 per meal (less than cost)



is suggested. Seniors in Plano pay an average of \$0.29 for meals that cost \$5.25 to produce.

Mark took over to continue the statistical onslaught. He pointed out the 150% increase in seniors in Collin County between 2000 (39,000) and 2010 (98,000). As evidence, he mentioned that he was 50 and guessed the average age of the assembly to be about that. **Ean** said, "*Jessica*, *stand up*."

In Plano alone, 39,674 meals were served last year. (That's only 25% of their business in the County. Since the City's population

represents about 40% of the County, seniors outside the City are ~60% needier



than Plano seniors.) Politics, he claimed. do not enter into the One wonders issue. what he smokes when no one is watching, because it's either that or he's incredibly naïve.

Mark claimed the **MOW** met our Four-Way Test, and the floor was turned over to questioners.

**b**, the President Formerly Known as Prince, wanted to know from whence cometh the food. He was told that **MOW** buys from distributors, and volunteers deliver meals. Those same volunteers serve as check-in monitors for the health and welfare of clients.

They have saved lives. rescuing clients who have fallen.

Mark also mentioned the holiday programs hosted for seniors. including a holiday box and Secret Santa.



Cary wanted him to promote the web site (given above) for those wishing to donate.

Someone asked about waiting lists, and they were told that there are none. Oualification is immediate.

Kirk Bell wanted to know if the volunteers all have to drive to MOW's McKinnev headquarters to pick up the lunch boxes, but the organization maintains two drop sites in Plano instead.

Brad the Non-Impaler Keith asked about the number of meals a client can receive daily. Mark said that it is just the noon meal, and if the City funds it and the client qualifies, the dinner meal is brought at the same time as the lunch meal, 11 am to 1 pm, and refrigerated.
