

THEN Jamie got to regale us about (100% Paul Harris) donating to the RI Foundation, endorsed by no less than founder and (former) CEO of the



sons. She has volunteered with Boy Scouts even as she was employed by BSA. Adult volunteers help scouts mature. Tamara intends to volunteer for BSA well after her children graduate from scouting. claims BSA finds "relevant resources to develop children" to become good citizens.

BSA has been guiding kids since the Era of "President Taft and the first Ford assembly line." But the kids are not conversant with those nobles nor the fact that we had only four TV channels (three broadcasting companies and a test pattern) as youths.

They will be given separate (but equal, no doubt) dens but then come together as a pack. They will go on campouts together, and the girls can earn advancements just as the Cubs have always done.

In 2019, Boy Scouts become coed. And the girls therein can earn merits up to and including Eagle Scout. But, in a surfeit of accommodation, BSA is surveying each chartering organization (including Plano Rotary) for their opinions on this move. If they and the Troop itself agree, all is well. If they disagree, the chartering organization may lose the Troop, which must then find another.

With the addition of girls, BSA now encompasses "the entire family." But the move is not without controversy. It would seem prima facie to cannibalize the market for Girl Scouts! Tamara denies this; BSA is seeking a more adventuresome brand of girl. Sainted Editor couldn't resist piping up, "So tomboys then." "Exactly," chimed Tamara, without missing a beat, and she and Carrolyn proudly proclaimed themselves to having been such.

Circle 10's four camps cost ~\$300 per camper for their experience, but that's to be compared against the ~\$18,000 it costs to incarcerate the lawless.

"I'd rather have them in Boy Scouts," opined the speaker, with confidence in no argument from us.

She spoke of how "their eyes light up" when they first don the uniform and how happy they are when first introduced to camping. She said that BSA has reached out to millions of Americans. 


