PISD Board of Directors President **Nancy Humphrey** introduced **Lynn Ojeda**, Principal at the *PISD Academy High* with a cry of "Go, Longhorns!" in honor of her alma mater.



Born and raised in Longview, Texas, Lynn Ojeda joined PISD in 1991 upon graduation from *Stephen F. Austin State University*, where she received her Bachelor of Arts degree in Spanish, English, and Secondary Education. Ms. Ojeda's career in education encompasses 13 years as a Spanish teacher and earning honors including being named *Haggard Middle School's* Teacher of the Year as well as...Texas Middle School Spanish Teacher of the Year by the *Texas Foreign Language Association*.

Ms. Ojeda earned her Master's Degree in Secondary Education with specialization in English and Linguistics in 1999 from the *University of North Texas*. She later returned to UNT to earn a second Master's Degree in Educational Administration in 2007. Ms. Ojeda has served as school administrator for 11 years, most recently as principal of *Williams High School*, where she opened the *Plano ISD Health Science Academy* in 2013. Collin County LULAC Council named Ms. Ojeda the Educator of the Year in 2013.

Lynn and her husband, **Homero**, have three children, daughter **Maya**, a student at *Collin College*, son, **Jory**, who attends *Clark High School*, and **Jacob** at *Hedgecoxe*.

Ms. Ojeda served on the Visioning Committee for academy programs in Plano ISD, and is thrilled to join the Titan Family this year!

I have had the personal pleasure of knowing Lynn as the principal of Williams High School when both of my children were there. I've witnessed first-hand her passion for students and dedication to our district's goal of continued improvement in student learning. And as you will see shortly, she has an amazing gift for articulate communication. (No pressure.) It is under great campus leadership of principals like Lynn Ojeda that Plano ISD continues the excellence in education for which the district is known locally, statewide, and nationally.



Lynn thanked Nancy for such a warm introduction and said she was pleased to be a part of the growth of our district due to the efforts of the Board. She apologized for her wet shoes with the caution, "*Beware where you are standing around 9<sup>th</sup> graders*" with water hoses.

She is still in communication with her former teacher, **Ms. Strochall**, who "*must be ancient*" but certainly appreciative of the email she received from Lynn during Teacher Appreciation Week lauding her for the results of "*her investment in a child...me*." Indeed, she became a Rotary Exchange Student on Ms. Strochall's recommendation and spent it in Barcelona where she also picked up the colorful banner presented today by Chris (of Park Guell "*Gway*," the unfinished home of **Gaudi's** patron).



Ms. Ojeda described her Academy as "*next door to Harley Davidson*," the correctional-looking facility near the SW corner of Alma and Park. But far from a prison, it is a high school campus housing 9<sup>th</sup> through 12<sup>th</sup> grade students learning in an entirely project-based environment. For example, 10<sup>th</sup> grade is engaged in an entrepreneurial project inspired by Yoram Solomon. They are designing a 3D printed, Bluetooth mouse ring! (I wasn't aware that mice wore bling!) And it would lead to an internship that "*could be life-changing*."

Indeed all seniors need to do an internship of at least 30 hours. Some take advantage of **Mayor LaRosiliere's** internship program, but the difference is, the students become interns in "*whatever they say they want*." And those 72 rising seniors come up with a wide variety of requests, including equine science (that's one way to finally get a pony), engineering, medicine, etc. And it is Lynn's job to match those requests with appropriate internships in the community. She then made the first of several plugs for partnership with Rotarian businesses, indicating a list of interests on the badge table we could peruse. So she's "*less of a principal, more of an agent*."

Seniors complete a Capstone Project that can be anything from writing a symphony to assembling a collection of art. One recent one involved a study of repetitive stress injury among DFW baggage handlers! Needless to say, mentors are a large part of her effort.

Her first teaching position was in *Hendrick Middle School*, and she still recalls **Wayne's** visit to his school.

A more descriptive appellation for her High School Academy might be "*Loophole University*." The students



are exceptionally creative, and companies offering them internships can benefit greatly from innovative “*problem-solvers.*”

As an example, a student project fruit juice was pitched to **Pepsico** with the suggestion that the container be molded with Braille labels. They’d never considered that market. This sort of out-of-the-box thinking will “*blow your mind.*”



The 11<sup>th</sup> grade was challenged to sell a soluble, gas, and art project and came up with a business plan, *Thanks a Latté*, which was funded to produce acrylic discs cutouts to put the State of Texas in foam on coffee. So trust her to send you “*my very best to do amazing things!*”

She hawked sponsorship logos on the robots build by her “*Rookie All-Stars*” in their international competitions.

**Ken Roberts** asked “*How many marketers*” are devoted to this? “*Just me,*” came the reply, although members of PISD’s Education Foundation “*also proselytize.*”

Nancy mentioned PISD’s *Health Science Academy* as another magnet school.

**Alex Johnson** wanted to know if Texas State legislation impedes her efforts, but she said that the expectations of the Teacher Education Agency are being met. “*The test takes care of itself,*” was her explanation. She examined the old saw about leading a horse to water and concluded “*we make the horses thirsty for knowledge.*”




Earnest wanted to know why there were no internships sought for CPAs, and Lynn
