Blair Ritchey was called upon for the prayer as usual, thanking our good and generous God for his blessings to us, for Rotary both locally and worldwide working to make the world a better place, and invoking his blessing on our meeting, food, fellowship, and ongoing efforts. Led by Paul Hernandez, and still feeling inspired by **Bob Epstein**, the club enthusiastically pledged to the flag. Blair Ritchey then took up his photographic duties for the Reader, and Rick Horne offered praise to the Greeters, Maria Mott and Daniel **Askari**. President Rick then permitted Jason Kramer, our youthful Sergeant-at-Arms, to take possession of the microphone, urging him to move things along quickly due to the plethora of agenda items. Jason



thanked the president for boosting his ego with the enthusiastic intro, and the club for its uncharacteristic applause. Jason introduced a strangely familiar visiting Rotarian, John **Ernst**, from the St. John's club.

enthusiastically applauded the two new members as they received the pins. Whatever happened to the moving candlelight ceremony tradition?

Mary Jo Dean was called upon to introduce the speakers, Tom Venner and Andre Davidson. Mary Jo is an alumni of Leadership Plano. Tom is a recent graduate of the program and a member of its board. Andre is a past director. Mary Jo claims credit for Andre's recruitment into civic volunteer work long ago.

Tom Venner expressed the



Leadership Plano's director Carole Greisdorf's regrets that he could not attend our meeting. He called for a show of hands from the Rotarians who had participated in Leadership Plano,

and about a dozen responded. Venner explained that **Leadership** Plano was a Flagship Program for the Plano Chamber of Commerce. Leadership Plano is dedicated to educating, developing, and empowering current and future leaders for the community and motivating them to serve civic, charitable, and business organizations. The program

has run for 35 years, and almost 1000 graduates have completed it. Graduates have served on the city council, the school board, and many other volunteer boards. Leadership Plano is designed to enhance

individual and community leadership skills. Leadership Plano introduces participants to the City Council, the School Board, Public Safety, non-profits, etc. It is a 9-month program, beginning with a mandatory 2-day retreat in September. Beginning in October and ending in May, the class spends one day per month examining specific aspects of the community

such as: education, area government, local business and economic development. health and human services, the criminal justice system. the arts, and non-profit organizations. Thirty-six individuals are in the class. with half chosen from business and city leaders. Each class selects a class project in December. (At this point members of the 34th class enthusiastically provided voluntary input, briefly reducing us to chaos.) The class 34 project was supporting the PISD's Adult Transition Program. Practice

to develop interviewing skills during job interviews was provided. Any Rotarians interested in the next class must apply from March to June 15.



Andre Davidson took her turn at the microphone. She is chairman of the committee that developed Plano Prime. (Andre is a petite lady whose head barely was visible over the podium, which she acknowledged.) The success of Leadership Plano has encouraged the Chamber of Commerce to expand the program. She spoke about a new program, Plano Prime, designed for citizens over the age of 55 who had not found the time previously to participate in Leadership Plano. This new program gives them a belated opportunity for involvement. It also is open to older citizens who have just



recently moved to Plano. Plano Prime is similar to Leadership Plano, but it is accomplished in only 6 sessions, from 9:00 a.m. until 3:00 p.m., every 2 weeks. It is scheduled from mid-January to March. The cost is \$500 for an individual or \$900 for a couple. The application is on-line at planochamber.org. or at leadershipplano.org. The application deadline is November 15, so if you are just learning of it from the Reader, you are too late for this year's session.



It gives new executives the opportunity to meet the city leaders and acquire some insight into the city's operation. It helps new employees in Plano to connect to volunteer organizations. Plano 36o is by invitation only. It will begin in the Spring.

Andre Davidson advised us that the chamber currently plans to alternate Plano 360 with a speaker series every second year. The series will feature high level, motivational speakers. All Plano citizens will be

welcome to attend the speaker series. (Sounds a little like Maribelle Davis' speaker series.) Andre asked our help in promoting the new programs to the community.




