

She said the Ball Drop has finally been sponsored (jointly by

Kelly Palmer and **Sainted Editor**). We are encouraged to come to the dinner to bid on auction items.

All the proceeds are destined for scholarships for students with crushing hardships. The **Hendrick Scholarship Foundation** not only funds tuition but also offers mentorship and educational planning as was envisioned by **Wayne Hendrick**, a masterful **PISD** Superintendant of many years. Wayne was born in Lovejoy, TX, to a family of 7 siblings! His mother insisted that all finish high school and four went on to college degrees.

Many of the **Hendrick** staff were present (not counting Board members **Mary Jo** and **Kelly**). **Lori Cecil**, Event Manager, wasn’t mentioned, but **Charla Fletcher**, Exec. Secty., was present at a table outside, collecting donations.

The Mistress of Ceremonies was **Marcy Wilson**, Executive Director. She spoke of the many beneficiaries of our largesse. She thanked Plano Rotary and said that the Foundation doesn’t take our help for granted. She wanted us to know that our help for her kids has a long-term influence.



She referred to one of her charges who told her, “*I won’t let you down.*” That is significant because as far as Marcy is concerned, Life has let all of them down. Theirs are tales of “*abandon, neglect, and abuse.*”



Marcy asked us to imagine what the world looks like from the perspective of such children who are told “*you don’t deserve to live. How do they view Life*” if it’s one long struggle for survival. **Hendrick Scholarships** have given them hope; they believe that “*Life has promise for them.*”



She mentioned **Alex S.**, a **Hendrick Scholar** who appeared before us in 2012. His parents, alcoholic and jobless, had divorced, and his brother had died. Alex works as a waiter but has maintained almost a 4.0 grade point average at **Collin College**. But one day, presumably exhausted by his schedule, he passed out and struck his head on the pavement. He awoke in the ER with raging headaches which have morphed into epileptic seizures. He was withdrawn from all his classes after the Drop Date, which means they were recorded as *Fs*. It appalled him to have those on his record, so he fought successfully to change them to *Ws*.

He apologized for “*having wasted the scholarship.*” But he has been reinstated and taken summer classes to get back on track. Without insurance, his involuntary hospitalization has come at a horrendous cost. The hospital has offered him a (presumably multiple lifetime) payment plan. The epilepsy has denied him the right to drive, so he rode the bus to his job and now is back in school doing “*all right.*”

He apologized for “*having wasted the scholarship.*” But he has been reinstated and taken summer classes to get back on track. Without insurance, his involuntary hospitalization has come at a horrendous cost. The hospital has offered him a (presumably multiple lifetime) payment plan. Marcy had brought another two students to tell their tales. She seeks those willing to bear all, but most of the 50 have backed out as being too humiliated to explicate their circumstances. Some find, however, the experience cathartic; once they start, they are compelled to confess all. Fortunately, **Ryan Phillips** and **Kyle Edwards** stuck to their scripts, or we’d still be there.



Ryan is a Mechanical Engineering major at **Collin College**. He was four years a cadet with the **Civil Air Patrol**. (**Scary Bob** must have perked up.) That experience “*gave structure to my life.*” It was necessary as he suffers dyslexia. It makes him “*good at History but bad at Reading and Writing.*” The Cadet Corps helped him develop social skills and gave him an abiding curiosity about how

airplanes work. This, in turn, fueled his interest in Mechanical Engineering. He praised the Hendrick Scholarship program for helping his career, and he thanked us for our generosity.



Kyle told us that he too attended Collin College. He comes from East Plano from a single parent family with four children. His father was an alcoholic and drug addict; his legal woes impressed Kyle as things devoutly to be avoided. Troubles at home meant that he lost his position as the School Mascot. However, he now dreams of a degree in Broadcasting from North Texas State University. Hendrick has "truly blessed" him, and, when he graduates, he'll be the first in his family to do so. He too thanked us.

Marcy introduced **Marty Taylor**, a HSF mentor and former PISD teacher and counselor. Marty thanked Rotary by extension for sending a daughter on a GSE. She told us of the trials



(literally) and tribulations (figuratively) of one of her mentees, **Julia Moore**. Julia missed three days of school due to a lockup in Juvenile Detention. A domestic disturbance at home had been attributed (falsely, so she claimed) to her, and when she was released, she refused to go home. Marty consulted with the PPD liaison officer, who, on seeing the address of Julia's home, recognized it as one of several disturbances he had been privileged to address. So she was referred to Juvenile Advocacy that situated Julia with her aunt in South Dallas. She commuted to PESH via DART but could not run to her first morning class, so she

was transferred to her grandma's home in Detroit where she graduated high school.

Marty contacted Dr. Hendrick who simply asked, "Is she a good one?" and, on getting affirmation, added her to the HSF list. Julia worked full-time and attended college full-time, amazing Marty with her perseverance. But Marty has since seen that in all of her charges, and she invites us to witness it for ourselves. She counsels that there is a *Handbook for Academic Coaches* (which are the re-name of program's mentors). They need college grads.

She finished with a quote from **Paul Shane Spear**: "As one person, I cannot change the World, but I can change the World of one person." There are 16 new Hendrick Scholars, so the need for Academic Coaches has never been higher.

Earnest Burke swore blind that his photo did not grace the highly-coveted perpetual calendar he gifted both students. Some wag noted, "That's why it's highly-coveted!"

Earnest led us in the Four-Way Test, and handed the gavel to both students who struck us gone at 1:04.


