


he nearly drowned as a youth. (What's fun


Last year's crowd was estimated at 19,000, making it an attractive venue to get out Rotary's word. Last year's Rotary booth featured information on Polio Plus and a hand-cranked water pump for its Clean, Safe Water projects. She's asking for volunteers for two-hour timeslots. And RYLA scholarship winners are expected to participate.

Kelly Palmer wanted us to know that Jeff Beckley is scheduled to compete in this year's **IRON MAN** event. He said we should gig him on his return about the Little Debbie treats they hand out.

Olin Jaye then introduced Brian *ex-McKinney Mayor* Loughmiller, advocate for the upcoming Collin County Bond Election. Apparently relevant to this is his advocacy for motorcycles. Their safety is at issue on Collin County freeways? Olin remarked that ours has been the fastestgrowing county in Texas, and the only one with a Planning Board! Brian is an attorney, but we didn't hold that against him. However, he has been an **IRON MAN** participant and had swum the Ohio River aka sewage.

Brian commented that the **Little Debbie** treats are after you burn 1,000 calories in the competition, so they have little effect. He's grateful to Rotary for getting "*my daughter off my payroll.*" (???)

Collin is the  $6^{\text{th}}$  most populous county in Texas with a population of 1 million in 2018-19, but by mid-century, we'll be #1 in population. So the bond issue is planning for that future.




There are 900K vehicles registered in the County, all using our roadways (in conjunction with the several hundreds of thousands passing through).


Locally, Dallas and Tarrant Counties "*get the bulk of Texas revenues*," but Collin will give them a run for their share of those monies, even as we build out around 2045. Current population density maps of Collin show us huddling in the SW quadrant, but at buildout, we saturate.

Collin County Mobility Plano 2014 Update Addendum 1 grades many of our roads an "*F*" by virtue of having more traffic than they should bear. In contrast to Dallas and Tarrant Counties, we have but two freeways, 75 & 121. We have to do better.



The ~\$4.7B proposed breaks down to

- Freeway summary \$2.3B
- Bus Rapid Transit **\$0.012B**
- Roadway Improvements **\$1.7B**
- Non-Regional Arterials \$0.6B

Indeed, **\$4.7B** won't cut it because by buildout (2045), we will have needed **\$12.6B**!

The Bond Package calls for **\$0.6B** for non-tolled freeways and **\$0.14B** for thoroughfares. The new freeways are 20-year projects. So don't plan on moving anywhere quickly until 2038. (The *Geriatric Club of Plano* 

should only live so long.)

Actually, construction congestion is put off until 2023. The run-up to that date is the Era of Pre-Construction: design, letting of contracts, acquisition and of right-of-way. All of this planned inconven-



ience is in the name of a free flow of traffic in the County.

As a sop to aesthetics, \$0.01B will be earmarked for open space and parks, with a like contribution coming from cities benefitting. That brings the total proposed for this November's ballot to:

- Non-tolled freeways, \$0.6B
- Thoroughfares, **\$0.14B**
- Parks & Open Spaces, \$0.01B
- Total: **\$0.75B**

A modest start to the **\$4.7B** required. And, of course, the take-away was:

#### If passed by voters, the November bond election will not increase the County's debt service tax rate.

Olin asked Brian about the 380 Project, specifically, how to "create mobility." Brian

pointed to the impracticalities of the project as regards freeways: there is not sufficient rightof-way. Perhaps a bypass is needed. But the question is how to route such a bypass for the lowest impact on homeowners in the area. TXdot will hold townhall meetings on the issue (at sites remote from 380 itself).

In response to Olin's second question on the fate of US 75, Brian told him that the expansion into northern Collin and southern Grayson counties will depend on the capture of Texas State funds, and the Council of Governments "*needs to be ready to cost match.*"

**Johnny Lewis** wanted to know about "*reclaiming the HOV lanes of 75.*" That's not a topic at COG; they talk of "*managed lanes*," but there are "*federal regulations against converting free to toll lanes.*"

Kelly Palmer said that the County needed 380 and an outer loop. Brian told him that would cost \$2.3B plus another \$B for the outer loop and right-of-way acquisition. It also begs the question "where do you cross Lake Lavon?"

Carrolyn the Petite offered Brian our tiny flash drive. Janis praised **Jo Via** for stoicism in the face of the Bal-



loon Festival rainout. Carrolyn led the 4-Way Test and belled us gone at 12:49.


