Leaving a Legacy

This past month we learned that two of our most active Rotarians are relocating to lower elevations and warmer climates. Although they're leaving our Club, they intend to continue in Rotary, and I'm sure they'll make a great contribution in their next Club too.

Dick Masica has been a Rotarian here for 11 years. He served as Chair of the Club's World Community Service committee and led major matching grant projects that provided equipment, furnishings, and transportation related to a special school serving the poor and handicapped students in Manchay, Peru. He coordinated several Rotary Clubs with another matching grant to serve an orphanage in Cabo San Lucas. Dick served for six years on the Board of our Charitable Fund including several years as Chair. His financial contributions to our Scale the Summit program took him well beyond Peak 10, and earned recognition from Rotary International as a Paul Harris Fellow many times over.

Steve Levine joined our Club in late 2009, and stepped right into leadership of the annual Car Raffle fundraiser, achieving net income before sponsorships greater than that of our other two fundraiser events combined. He served as a subcommittee chair for BBQ, and this past year he joined Betty and Rob on the BBQ leadership team to help implement several major improvements in that event. We'll miss both Dick and Steve, as well as other members who have moved on recently, but we're confident that many of our newer as well as longer term members are ready to step up to the challenges offered by Rotary.

What will be your legacy when you too eventually move on? This is a great time of year to consider what you'll tackle next in Rotary. Some of our Club leadership positions change annually, and most Board members change every second year. During the next few months, President Elect **Peggy Beeler**, Fundraising Director **Bob Lau**, and others will be filling many future leadership positions. GONE WAY TOO FAR!

TURN LEFT ONTO BOULDER CREEK ROAD, THE ROAD TURNS RIGHT ON A BRIDGE OVER BOULDER CREEK. YOU WILL SEE A SIGN THAT SAYS MEADOWBROOK ROAD. CONTINUE ON THE ROAD AS IT TURNS WEST (THE ONLY WAY TO GO) AND DRIVE WEST ABOUT 1 ½ MILES. THEN, ON YOUR RIGHT YOU WILL SEE OUR LOG CABIN, GO PAST THE CABIN AND YOU WILL COME TO THE DRIVEWAY- 2 SKIS MARK THE ENTRANCE AND FLAGS IF THEY ARE STILL THERE. ABOUT 30 FT INTO THE DRIVEWAY, YOU WILL SEE A BEAR HOLDING THE "EDELWEISS" SIGN. PARK ON THE ROAD ACROSS FROM THE CABIN FACING THE CARS DOWNHILL. SOMEONE WILL HELP DIRECT THE PARKING.

IF YOU GET LOST, GO TO HIGHWAY 9 UNTIL YOU GET CELL PHONE RECEPTION, AND DIAL OUR CABIN PHONE 970 513 1678 . . THERE IS NO CELL PHONE SERVICE ON BOULDER CREEK ROAD.

IF YOU ARE COMING FROM THE NORTH, JUST TURN ON BOULDER CREEK ROAD . . IT IS JUST SOUTH OF THE BRIDGE WHERE BOULDER CREEK JOINS THE BLUE. THE TURN IS THE NEXT ONE SOUTH OF SIERRA BOSQUE. CARPOOLING IS SUGGESTED AS THERE IS MINIMAL PARKING AVAILABLE. IF YOU ARE GOING FOR A HIKE, KEYS NEED TO BE LEFT IN THE CARS SO THAT THEY CAN BE MOVED IN CASE OF AN EMERGENCY.
