

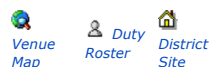

It's that time of year to begin collecting money to buy turkeys for the upcoming **Community Thanksgiving Dinner**. The last couple of years we have fed between 350 and 425 people.

The member collection typically comes close to the value of the birds; however, we still need to furnish the soft goods (plates, napkins, utensils, cups, etc.), and coffee, tea, punch, milk and water. Through an ECHO Grant, the Keystone Conference Center cooks the meat, provides stuffing, potatoes and gravy, green beans, salad, rolls, cranberry sauce, and pumpkin pie.

City Market gives us a great price for the turkeys, the Town of Silverthorne donates the Pavilion for our use, and the Summit Daily News places the ads for us. Please give a hearty *Thank You* to them when you can.
