Paul Harris, the founder of Rotary, is who we honor when we donate to The Rotary Foundation. When your Rotary Foundation donations add up to \$1000 (or equivalent with recognition points) you become a Paul Harris Fellow. The District Governor has asked the Clubs in our District to encourage giving to TRF by supplementing new gifts (gifts that bring the member to a new Paul Harris recognition level) with our Club Recognition Points (up to 500 points). The money that we gift to TRF will be used for Global Grants, District Grants, Ambassadorial Scholarships, Rotary World Peace Fellowships, Vocational Training Teams, and more. The Rotary Foundation slogan is <i>Doing Good in the World</i> . When we participate, we make it possible to receive grants for our club and to share in the work of Rotarians around the world.
