CHILD ABUSE AND NEGLECT

- In 2010, Kansas had 32,377 total referrals for child abuse and neglect. Of those, 17,379 reports were referred for investigation.⁸
- In 2010, 1,552 children were victims of abuse or neglect in Kansas, a rate of 2.2 per 1,000 children, representing a 13.9% increase from 2009. Of these children, 22.3% were neglected, 22.3% were physically abused, and 34.6% were sexually abused.⁹
- The number of child victims has decreased 41.0% in comparison to the number of victims in 2006.¹⁰
- In 2010, 6 children in Kansas died as a result of abuse or neglect.¹¹
- In 2010, 5,979 children in Kansas lived apart from their families in out-of-home care, compared with 5,691 children in 2009. In 2010, 2,103 of the children living apart from their families were age 5 or younger, and 1,045 were 16 or older.¹²
- The number of children living apart from their families in out-of-home care has decreased 4.1% in comparison to the number of children in out-of-home care in 2006.¹³
- Of Kansas children in out-of-home care in 2010, 65.6% were white, 18.2% black, 10.6% Hispanic, 0.8% American Indian/Alaskan Native, 0.4% Asian or Pacific Islander and 4.3% of more than one race or ethnicity.¹⁴

ADOPTION, KINSHIP CARE, AND PERMANENT FAMILIES FOR CHILDREN

- Of the 3,173 children exiting out-of-home care in Kansas in 2010, 52.7% were reunited with their parents or other family members.¹⁵
- In 2010, 694 children were legally adopted through the public child welfare agency in Kansas, a 17.0% decrease from 836 in 2009.¹⁶
- Of the 5,979 children in out-of-home care in 2010, 1,825 or 30.5% were waiting to be adopted.¹⁷
- In 2010, approximately 20,250 Kansas grandparents had primary responsibility caring for their grandchildren.¹⁸
- Of the 5,979 children in out-of-home care in 2010, 1,536 were living with relatives while in care.¹⁹
- Of all Kansas children in kinship care in 2010, 68.4% were white, 18.6% black, 9.2% Hispanic, 0.7% American Indian/Alaskan Native, 0.1% Asian or Pacific Islander, and 18.6% of more than one race or ethnicity.²⁰

CHILD POVERTY AND INCOME SUPPORT

- The total number of individuals receiving Temporary Assistance for Needy Families (TANF) in Kansas increased from 33,384 in 2009 to 37,588 in 2010, an increase of 12.6%. The number of families receiving TANF in 2010 was 14,588, a 11.2% increase from 2009.²¹
- From 2008 to 2009, for every 100 Kansas families living in poverty, only 23 received TANF benefits.²²

- In 2010, \$206,621,559 was spent in Kansas on TANF assistance, including 24% on basic assistance, 5% on child care, 4% on transportation, and 56% on nonassistance.²³
- In 2010, \$32,880,037 was spent on WIC (the Special Supplement Nutrition Program for Women, Infants, and Children) in Kansas, serving 77,363 participants.²⁴
- In 2010, Kansas distributed \$177,893,514 in child support funds, a 1.8% decrease from 2009.²⁵
- In 2009 in Kansas, 72,241 low income renter households paid more than half their monthly income in housing costs; 24% of these are families with children.²⁶

CHILD CARE AND HEAD START

- In 2009, Kansas had a monthly average of 20,900 children served by subsidized child care; 21,500 children received subsidized child care in 2008 and 22,500 in 2007.²⁷
- In 2011, to be eligible for subsidized child care in Kansas, a family of three could make no more than \$33,876, which is equivalent to 55% of the state's median income.²⁸
- As of early 2011, Kansas did not have a waiting list for child care assistance.²⁹
- In 2009, Head Start served 8,178 Kansas children, a 1.75% decrease from 2008.³⁰

HEALTH AND SUBSTANCE ABUSE

- In 2009 and 2010, 220,300 children younger than 19 were enrolled in Medicaid in Kansas—71% of the total number of enrollees in the state.³¹
- In 2009, 15,109 children were enrolled in Medicaid in Kansas on the basis of being in foster care.³²
- In 2009, of the 15,109 children enrolled in Medicaid on the basis of being in foster care, 2,289 received Targeted Case Management services, and 2,671 received Rehabilitative Services.³³
- In 2010, Kansas had 56,384 children enrolled in its State Children's Health Insurance Program, a 14.7% increase from 2009, when 48,090 children were enrolled.³⁴
- In 2010, Kansas had 53,000 uninsured children, representing 7.5% of its child population.³⁵
- In 2009, 3,011 babies were born weighing less than 2,500 grams in Kansas.³⁶
- In 2008, 304 infants under age 1 died in Kansas.³⁷
- In 2008, the birth rate for teens 15–17 in Kansas was 22 births per 1,000 girls; for teens 18–19, the rate was 80. This reflects a total rate of 46 births per 1,000 girls ages 15–19.³⁸
- Cumulative through 2009, 3,284 adults and adolescents, as well as 16 children younger than 13, were reported as having HIV/AIDS in Kansas.³⁹
- In 2008, an estimated 19,000 children ages 12–17 and 195,000 adults age 18 and older were dependent on or abusing illicit drugs or alcohol in Kansas.⁴⁰

VULNERABLE YOUTH

- In 2010, 427 children aged out of out-of-home care—exited foster care to emancipation—in Kansas.⁴¹
- In 2010, 7,000 Kansas teens ages 16–19 were not enrolled in school and were not working.⁴²
- In 2010, 33,000 young adults ages 18–24 were not enrolled in school, were not working, and had no degree beyond high school.⁴³
- In 2008, approximately 9,000 children ages 12–17 in Kansas needed but had not received treatment for illicit drug use in the past year.⁴⁴

- In 2008, approximately 13,000 children ages 12–17 in the state needed but had not received treatment for alcohol use in the past year.⁴⁵
- In 2008, 22 Kansas children younger than 20 committed suicide, a rate of 2.76 per 100,000 children.⁴⁶

JUVENILE JUSTICE AND DELINQUENCY PREVENTION

- In 2008, 18 children under age 19 were killed by a firearm in Kansas, a 50.0% decrease from 36 in 2007.⁴⁷
- In 2010, 8,127 children younger than 18 were arrested in Kansas, a 15.2% decrease from 9,585 arrests in 2009. Of the arrests in 2010, 328 were for violent crimes.⁴⁸
- In 2010, 843 children lived in juvenile correction facilities in Kansas.⁴⁹

CHILD WELFARE WORKFORCE⁵⁰

- A 2003 General Accounting Office (GAO) report documented that staff shortages, high caseloads, high worker turnover, and low salaries impinge on delivering services to achieve safety, permanence, and well-being for children.⁵¹
- The federal Child and Family Service Reviews have clearly demonstrated that the more time a caseworker spends with a child and family, the better the outcomes for those children and families.⁵²
- According to the 2003 GAO report, the average caseload for child welfare/foster care caseworkers is 24–31 children; these high caseloads contribute to high worker turnover and insufficient services being provided to children and families. CWLA recommends that foster care caseworkers have caseloads of 12–15 children.⁵³

FUNDING CHILD WELFARE SERVICES FOR KANSAS'S CHILDREN

- Out of 5,979 children in out-of-home care in Kansas in 2009, only 1,245, or 21%, received Title IV-E federal foster care assistance.⁵⁴
- In 2006, Kansas spent \$288,966,692 for child welfare services. Child welfare services are all direct and administrative services the state agency provides to children and families. Of this amount, 27% was from federal funds, 73% from state funds, and 0.0% from local funds.⁵⁵
- In 2006, of the \$76,927,836 in federal funds received for child welfare, 60% was from Title IV-E Foster Care and Adoption Assistance, 7% came from Title IV-B Child Welfare Services and Promoting Safe and Stable Families, 0% was from Medicaid, 9% came from Social Services Block Grant, 16% was from TANF, and 7% came from other federal sources.⁵⁶
- Kansas received \$27,595,411 in federal funds for IV-E foster care expenditures in 2010, including \$14,813,153 for maintenance payments, \$13,549,938 for administration and child placement, and \$98,523 for training.⁵⁷
- Kansas received \$16,821,241 in federal funds for IV-E adoption assistance expenditures in 2010, including \$15,719,681 for assistance payments and \$1,101,564 for administration and child placement.⁵⁸
- In 2010, Kansas earned a total of \$0 in adoption incentive funding from the federal government for the proportion of children adopted out the state foster care system in 2010.⁵⁹

⁵⁰ Note: The dearth in current state-by-state workforce data makes clear the need for critical data on compensation, working conditions including safety issues, academic degrees held, education and training received, and factors contributing to turnover. To address this, CWLA is calling for Congress to authorize the National Academy of Sciences (NAS) to conduct an updated study on the child welfare workforce. It would make recommendations regarding caseloads and workloads, education levels, and training requirements. In addition, the study would examine data reporting and collection and make recommendations on how states might improve these efforts.
