

## Mike Haskin....Thank You For Serving With Olathe Rotarians Since 1981

Mike Haskin grew up in Olathe and his first encounter with the Olathe Noon Rotary Club came in the 1950's, when he played on the Little League baseball team sponsored by the Rotary Club. He got a t-shirt and a baseball hat that said Rotary, and he learned an important life lesson from the experience: he was not good enough at baseball to be a professional baseball player when he grew up, so he would have to find some other way of earning a living.

After he was graduated from Olathe High School (there was only one at the time, now it is Olathe North) in 1967, Mike went to Baker University and received a Bachelor of Arts Degree in 1971. He then attended the University of Missouri-Kansas City Law School and attained a Juris Doctorate

degree in 1976. Mike returned to Olathe to practice law with his father, Harley Haskin, and now, over forty years later, he still continues to practice law from his office in downtown Olathe.

Mike joined the Olathe Rotary Club in 1981, sponsored by his father (who had been a member of the club since 1939, only a few years after the club was founded). Mike served as President of the club in 1992-1993, and received the Rotarian of the Year Award in 1993. He has also received three Paul Harris Awards.

Mike has been active in community affairs for many years, and in 1989 he was elected to the Olathe City Council. After serving four years as a Councilman, he was elected Mayor in 1993. During his terms on the City Council and as Mayor, both the 119th Street and I-35 interchange and the 151st Street and I-35 interchange were opened and the city experienced tremendous growth. As Mayor, Mike was credited by many observers with bringing an era of professionalism and freedom from special interests to the Olathe City Council.

Mike has also been very active in supporting the arts in Olathe. He helped create the Hidden Glen Arts Festival and the Olathe Arts Alliance, and has served on both of their boards, as well as the Board of Directors of the of the Olathe Youth Symphony. Mike especially enjoys the theatre, and in addition to acting in many productions at the Olathe Civic Theatre, he has served as President of that organization. For many years Mike was also the chairman of the Olathe Public Arts Commission and helped institute the sculpture program for downtown Olathe.

Mike served as co-chair of the Olathe Sescquicentennial Committee, which, after three years of planning, hosted a number of successful public events in 2007 to commemorate the 150th anniversary of the founding of Olathe. The Committee also raised over \$400,000 in private donations to commission and purchase the Kwan Wu sculpture entitled West on the Santa Fe Trail which sits at the corner of Ridgeview and Old Kansas City road (right across the street from where our club normally meets). To show his gratitude to Mike, Kwan Wu sculpted an image of Mike as one of the passengers inside the stagecoach.

Last summer, Mike and his wife, Pam Lutz Haskin, sold their house in Olathe and moved to Gardner but to paraphrase Tony Bennett, Mike left his heart in Olathe. In the summer Mike spends many weekends at Stockton Lake in Missouri on his sailboat, and in December of each year he enjoys dressing up as a certain jolly old elf.
