Lieutenants Kory and Heidi Strand are officers of The Salvation Army, stationed here in Olathe, KS. They completed seminary with The

Salvation Army in the beginning of June 2016 and were sent here from Chicago, IL at the end of that month. This is their very first appointment and they are loving serving the community as pastors and administrators. Before serving in this capacity, they both attended The Salvation Army as their church while Kory worked as an IT professional and Heidi worked as a 3rd grade teacher. It was while working in their respective fields that God eventually steered them in a different direction, asking them to serve in full-time ministry.

Along with leading their congregation and Sunday services, the Lieutenants are in charge of all the day to day operations that take place. This includes a social services "umbrella" which incorporates assistance with rent, utilities, and prescriptions, a weekly food pantry, and even a transitional housing shelter for families. The shelter is a program that helps families go from brokenness to stability, often leaving the program with stable housing and employment, money in the bank, and ongoing strategies to continue to succeed. While in the program, these families have dinner meals provided, take finance and parenting classes, and check in weekly with our case managers. The Salvation Army also runs a program entitled "Pathway of Hope" which continues long term case management that gives individuals and families a chance to take further steps towards stability in their lives. Overall, it is a very busy place that is continually helping people to meet their most basic needs with the plan being that it will go further than that.

The Strands, along with their children Jack and Olivia, love the Lord Jesus Christ and are proud to serve Him in The Salvation Army. It is there where they are able to see the needs that face the people of Olathe and Johnson County. It never stops, but they feel privileged to be able to meet those needs, without discrimination, in the name of Jesus. In their limited free time, Kory and Jack love to watch and play football and baseball (Go Cubs!), while Heidi loves to read and have "girl time" with Olivia. They cherish the time they have to spend together as a family of four, and they look forward to continuing to serve the people of Johnson County. They have fallen in love with this community and are thrilled to be a part of the Rotary here in Olathe!
