The Waterloo Rotary Club has partnered with the Community Foundation of Northeast Iowa by establishing funds to benefit the charitable purposes of its organization. Your contribution to any of the following funds will help carry out the mission, programs and experiences supported by the Waterloo Rotary Club.

Waterloo Rotary Shoebox & Layette Project Fund

Donations to this fund are to be used for the purchase of Layette and Diaper Bag type of items to be sent to African mothers.

Waterloo Rotary Reserve Fund

Donations to this fund are to be used for any charitable purposes of Waterloo Rotary Reserve.

Waterloo Rotary Youth Activity/Fred Adams Endowment Fund (Quasi)

Donations to this fund are to be used to benefit youth in the Waterloo community. This fund also provides scholarships to students at UNI, Allen College of Nursing, and Hawkeye Community College.

Waterloo Rotary Foundation Charitable Endowment Fund

Donations to this fund are to be used for any charitable purposes of Waterloo Rotary. This fund is a permanent fund with only income from the fund granted out.

Endow Iowa legislation makes donors to this fund eligible for a **25% state tax credit in addition to the normal federal deductions for charitable giving**. To receive the tax credit, the fund must be endowed with a community foundation that meets national standards, like the Community Foundation of Northeast Iowa.

Establish your own named fund

Anyone with a gift of \$5,000 or more may establish their own named fund. Income from the fund may be designated for the charitable purposes of the Waterloo Rotary Club.

Note: Funds may be established to benefit multiple charitable purposes.
