Introduction to the 2023 MUNA ASSEMBLY

The Secretary General António Guterres

António Manuel de Oliveira Guterres GCC GCL is a Portuguese politician and diplomat. Since 2017, he has served as secretary-general of the United Nations, the ninth person to hold this title. A member of the Portuguese Socialist Party, Guterres served as prime minister of Portugal from 1995 to 2002.

The 193-member General Assembly elects the secretary-general for a five-year renewable term. Antonio Guterres was elected for 2nd 5 year term in June 2021

The post is often filled by candidates from smaller, neutral nations.

The Security Council

The United Nations Security Council is charged with the maintenance of international peace and security. The Security Council is made of 15 member countries.

5 of the countries are permanent members. They are based on the great powers that were the victors of the 2^{nd} World War and are:

China

Russia

France

United Kingdom

United States

The other 10 members are non-permanent with 5 being elected each for a 2 year term.

Albania, Brazil, Gabon, Ghana, United Arab Emirates, Ecuador, Japan, Malta, Mozambique, Switzerland

The Veto

Security Council decisions on all substantive matters require the affirmative votes of nine members. A negative vote, or *veto*, by a permanent member prevents adoption of a proposal, even if it has received the required number of affirmative votes (9)

MUNA Rule Summary

Rule 1: Permission to Address the Assembly

In order to maintain order, permission to address the Assembly can only be granted by the Secretary General. Delegates when called upon to speak, for example I might so something like, "I now call upon the representatives of Tunisia." That delegate should stand, wait for the microphone and begin with, "Mr Secretary General, we the delegates from... Tunisia

Rule 2: Debating a Resolution

When a resolution is to be debated the Secretary General will call for (by show of hands)

- 1. Proposer
- 2. Seconder
- 3. Then all those who wish to speak FOR the motion
- 4. Then all those who wish to speak against the first speaker against is the Principal Speaker against
- 5. Speakers will then speak For and Against in turn
- 6. At the end of the speeches the Proposer and the Principal Speaker against have the opportunity to make closing statements. These should be used to summarise their case and rebut the arguments of the opposing side BUT not to introduce new arguments

Rule 3: Amendments to a Resolution

The Secretary General will seek the acquiescence (agreement) of the original proposer and seconder of the motion – if accepted it becomes the new resolution.

If not the amendment can be withdrawn or it can be put to a vote of the assembly.

NOTE: the Secretary General will limit the number of amendments, they will only be entertained if it is obvious that the original resolution is doomed and that a minor modification that does not challenge the integrity of the original resolution could result in a successful resolution being put.

Rule 4: Point of Order (P of O)

- 1. Any delegate can stop proceedings by rising in their seat and when recognised by the Secretary General ask for a ruling on a Point of Order
- 2. A point of Order refers to an <u>issue of fact</u> that needs to be disputed or if the <u>behaviour of a delegate</u> is questionable.
- 3. For example, a delegate may make a slanderous comment about a country's leader or make a grossly inaccurate comment about a country.
- 4. To be upheld by the Secretary General they must be based on well-accepted fact and not opinion.

NOTE: P of O's will be limited as they interrupt the flow of debate

Rule 5 Leave to make a statement

Granted by the Secretary General only to clarify an error in debate.

Rule 6: Motion of Dissent

Delegates can introduce these if in their opinion the Secretary General <u>is showing bias in his rulings or his conduct of proceedings.</u>

Procedure:

- 1. Motion of Dissent is proposed
- 2. Motion is seconded
- 3. The Secretary General vacates the Chair in favour of the President
- 4. Motion is put to the vote.
- 5. If successful the S.G. vacates the chair for the rest of that debate.

Rule 7: That the motion be put

If a debate is going nowhere and speakers do not appear to have any thing new to say, any delegate can move that the motion be put.

Procedure:

- 1. At a suitable break the delegate gains the attention of the Secretary General
- 2. Motion is seconded
- 3. If carried all debate ceases and a vote on the resolution is called
- 4. If not carried the debate can continue.

Rule 8: Diplomatic Notes:

These are usually passed between Block members or are used to assist members who are yet to speak.

Use them sparingly and not for social reasons as they can become disruptive to the operation of the debates.

NOTE: the Secretary General will reserve the right to intercept diplomatic mail.

Rule 9: Suspension of Standing Orders

These are used by the Secretary General to interrupt proceedings to acknowledge the arrival of specific people such as the Rotary District Governor

BLOCS

For the purpose of discussing strategies to best achieve their desired result, countries are placed into blocs. Whilst the blocs below attempt to follow logical groupings, they have been adjusted in order to keep them with reasonably equal numbers. It is up to countries to call for a bloc meeting when required and such meetings should only be very short. Generally, in the order of 10 minutes.

RESOLUTIONS

Security & The Middle East

- 1. That this Assembly supports the division of Israel and Palestine into three parts: an Arab State, a Jewish State and the City of Jerusalem, jointly controlled by both states and with neither state able to adopt Jerusalem as its capital.
- 2. That this assembly condemns the Israel for its ongoing expansion of Jewish settlements on land Palestinians claim for a future state and consider these settlements are considered illegal under international law.
- 3. That this assembly calls on the Democratic People's Republic of Korea, the State of Israel, Pakistan and India and any other country that has embarked on a nuclear weapons program without signing the nuclear weapons non-proliferation treaty to submit themselves to the same international controls as the Islamic Republic of Iran.
- 4. That this assembly condemns the People's Republic of China for increasing its military activities in the in the region of the Republic of China (Taiwan) and the Pacific Region in general. This action is causing neighbouring countries to use much needed financial resources to bolster their own military power in case they need to defend itself against China resulting in a deterioration of the world economy.
- 5. That this Assembly strongly condemns the Russian Federation for its unwarranted invasion of Ukraine that has resulted in the destruction of whole cities and the loss of life of over 8,500 Ukraine civilians and 13,000 soldiers as well as about 70,000 Russian soldiers.

Health & Education

- 6. That this assembly requires all primary and secondary schools in member states to implement compulsory health/sex education to limit the effects of excessive population growth and the spread of sexually transmitted diseases
- 7. This assembly again calls upon the United States of America to take the necessary action to reduce violence and unnecessary deaths by introducing credible gun control laws.
- 8. That this Assembly requires all member countries to agree to provide free compulsory education for all children upto the age of 14 and strongly condemns the Islamic Emirate of Afghanistan for not permitting any female education beyond primary school

Human Rights

- 9. That this assembly condemns the counties of Switzerland, Netherlands, France, Sri Lanka, Belgium, China, Austria and Bulgaria for forbidding Muslim women from wearing full faced veils in public and also condemns all Muslim countries that force Muslim women to wear full faced veils in public
- 10. That this assembly call upon the Commonwealth of Australia to fulfil its treaty obligations and cease its practice of mandatory detention of asylum seekers who arrive by sea, grant them the same legal rights as its residents and process their claims within Australia.
- 11. That this assembly condemns the government of the Democratic People's Republic of Korea for not tolerating pluralism, for its bans on independent media, civil society organizations, and trade unions, and its systematic denial of all basic liberties, including freedom of expression, public assembly, association, and religion. Its use of fear of collective punishment to silence dissent. As well as it routinely sending perceived opponents of the government to secretive political prison camps (kwanliso) in remote regions where they face torture by guards, starvation rations, and forced labour.
- 12. That this assembly condemns countries that still have laws that criminalize homosexuality
- 13. That this assembly condemns the Islamic Emirate of Afghanistan for wholly excluding women from public office and the judiciary and for requiring them to adhere to a strict dress code and not permitting them to travel more than 75 km without a mahram and compelling them to stay at home.
- 14. That this assembly condemns Saudi Arabia for its Human Rights breaches which includes lack of freedom of expression or association, unwarranted use of the Death Penalty (including Public Executions) and its discrimination of women including through male guardianship

Environment

- 15. That this assembly urges all countries to phase out all use of coal as a means of electricity generation.
- 16. This assembly condemns the actions of Japan to ignore the ruling of the International Court of Justice to resume whaling in the Southern Ocean. It calls on Japan to acknowledge that their claim that the killing of whales is scientific research is sham to disguise the reality of its commercial whaling.
- 17. This General Assembly recognizes the right to a clean, healthy, and sustainable environment as a human right. The UNGA calls upon States, international organizations, businesses, and other stakeholders to "scale up efforts" to ensure a clean, healthy, and sustainable environment for all. Furthermore, it calls on the 5 countries with the largest carbon emissions to make even more substantial improvements. These countries in order being China, United States, India, Russia and Japan.

Trade & Commerce

- 18. This assembly calls upon member countries that source manufactured goods from other countries pass legislation that requires the importers to only source goods that are made by factories that comply with basic child labour, living wage and safety laws.
- 19. That member states are urged to pass legislation requiring pharmaceutical companies having manufacturing facilities within their territories to supply drugs at the cost of manufacture to developing countries for use in combating pandemics.
- 20. That this assembly demands that all countries that supply uranium ore for the nuclear industry are required to accept the return used enriched uranium waste materials for safe storage.
- 21. This Assembly recognises the scientific and social importance of the use of genetically modified plants for commercial agricultural purposes. It urges member states to support the research and development of genetic modification technology to boost crop yields and food quality, so that local and global food shortages can be addressed more effectively.
- 22. That this assembly condemns China for its open acceptance of copyright breaches in its country resulting in copies of world recognized branded products being devalued by much cheaper copies flooding the world market. If it does not take action to prosecute the companies partaking in this practice within 12 months this assembly should consider appropriate penalties to be applied to them
- 23. That this Assembly, being of the opinion that there is no credible evidence that the recreational use of cannabis is damaging to health, encourages the farming of hemp as a cash crop in developing nations.
- 24. That this Assembly agree that all countries should cease all trade with the Russian Federation until they stop their occupation of Ukraine

United Nations

- 25. That the Security Council acknowledges that India is the country with the largest population in the democratic world by admitting it as a permanent member and the privilege of the veto be withdrawn from permanent members.
- 26. The power of the permanent members of the Security Council to veto resolutions be only allowed if it has the support of one other permanent member or any 2 other Security Council members.
- 27. That this Assembly agree that when Palestine is able to finalize a 2 State agreement with Israel they will immediately be upgraded from observer status to full membership of this Assembly.
