

Terms and Conditions

Bristol Rotary will conduct the sweepstakes drawing live on November 17th, 2024, at Linden Place on Hope Street in Bristol, Rhode Island. Participants need not be in attendance. The person who purchased the selected sweepstake ticket (the "Winner") will be notified by phone and/or email as provided on their sweepstakes registration.

The Winner will receive travel credits through ATLANTIVACATIONS INC entitling them with their companion(s) to transportation, accommodations and dining of their selection (the "Prize) with a total value of \$10,000.00. The Winner will select the destination, the airline and hotel and to the extent possible dining arrangements.
