Mark described various activities the commission has been pursuing including the transmission line project, road projects and a tree planting and lawn project around the Courthouse, where chimney and structural improvements are also being made. On June 24, the Adair County Commission received \$2,973,240 in federal **Coronavirus Aid, Relief and Economic (CARES) Act funding**. Mark Shahan said that \$178,000 of these funds have been distributed this week. He said applications have been light.
