

Rotary Youth Exchange Program: Annette Sweet reported that host families are urgently needed for Isabella, our Rotary Exchange high school student from Germany, who starts at KHS this fall. The parents of exchange students appreciate the hospitality shown to their children by host families in Kirksville, as shown by this message sent to Annette:

Program: Tony Keene, CEO at Northeast Regional Medical Center, provided a report on the current status and future plans for the hospital. Tony's primary goal and that of the hospital's medical staff is to treat patients with value and dignity. NRMC is rated as a 4-star hospital by the Centers for Medicare & Medicaid Services and as a Level 3 Trauma Center. The hospital provides many high-tech services--including Tele-NICU services, 3D mammography, Tesla MRI, Dexascans, and 64-slice computed tomography--that make it unnecessary for local residents to travel outside the area for medical care. The hospital has 93 beds, 172 physicians on its staff, and partners with ATSU in its residency program. In 2021, NRMC serviced 11,100 emergency room visits and 1700 inpatient admissions, delivered 400 babies, performed 3200 surgeries, and provided 69,000 outpatient visits. The hospital paid \$4.6 million in taxes and \$23.5 million in salaries. The hospital provided \$8.3 million in charity and uncompensated care, and supported 13 community agencies.

Tony has been CEO at NRMC since August 2, 2021. He holds BS and MS degrees in Business Adminstration and is active on a number of community boards. He and his wife, April, have been married 27 years, have 3 adult children, and have been foster parents for a number of children.
