## "YOUR MISSOURI COURTS: PROTECTING LIBERTY & JUSTICE FOR ALL" ADAIR COUNTY ASSOCIATE CIRCUIT JUDGE KRISTIE J. SWAIM



Dale Schenewerk provided some background on today's program. He said President Melissa received an email which mentioned "Have Gavel, Will Travel" Civic Education program sponsored by the Supreme Court of Missouri. The above program is one of many programs available (if you are interested in pursuing). Judge Matt Wilson was assigned the program presentation but was not available today so he found Judge Kristie Swaim to cover for him. She was a good choice!

Judge Swaim received her undergraduate degree from the University of Iowa in Political science before attaining her law degree from the University of Missouri Columbia. She had a private practice from 1993-2002 and during that time she served a term on the Kirksville City Council. Since 2003 she has served as an Adair County Associate Circuit Judge. Her judicial-related service includes participation on numerous

committees and boards over the past 20 years including the Civic Education Committee which brought her here today.

Judge Swaim discussed this case: **State of Missouri v. John Rowe** (2002). John Rowe\* appealed the judgment of a trial court following a jury trial in 1999. Defendant had been convicted of driving while his license had been revoked (in Iowa) in violation of Section 302.321, RSMo 2000, and was sentenced to three years of imprisonment and fined \$1000. The appellate court in St. Louis affirmed the conviction. The Missouri State Supreme Court, however, ruled that without the language "under laws of this state" the defendant cannot be charged with this felony in the State of Missouri. "The statute is clear. This court cannot rewrite the statute." The case against John Rowe was returned to the Missouri county of original conviction where lesser charges were pursued. The Missouri State Legislature subsequently added the appropriate language to the statute.


