KIRKSVILLE ROTARY CHARITABLE FUND: Charitable Fund President Amanda Brand greeted us and turned the meeting over to Jeff Romine, Charitable Fund treasurer. Jeff said the Charitable Fund was formed on February 2, 1996, a vision of Ray Klinginsmith. Its purpose was to support Rotary projects such as our Free Enterprise Award. It is a Missouri Not-for-Profit with 501(c)(3) status. We are currently in good standing with the Missouri Secretary of State and listed among the IRS's charities. It is a separate organization from either Rotary clubs in Kirksville. Its board of directors consists of five past presidents and four members at large. In addition to the Ruby Green Frank Baldwin Free Enterprise Award, it also helps with the Ray Klinginsmith award, Rotary park project and "Do Good" projects. It has previously supported the Ray Klinginsmith Amphitheater, formation of FLATS and their first grant, Thousand Hills' Days for Girls, Shoes for Orphan Souls and the carpet project at the Nazarene Church. The Charitable Fund, our philanthropic organization, classifies resource into three classes of net assets as follows: Unrestricted, Temporarily Restricted and Permanently Restricted (see Notes attached for description).
