Corporate Membership Summary



Purpose of Corporate Memberships:

The Corporate Membership Program will allow a corporation or a company in the club's area to become a member of the Parkville Rotary Club, through the currently established membership approval process. The intent of the corporate membership category is to increase the club's ability to attract and retain a qualified and diverse professional base within the community. It allows for flexibility and recognizes the tremendous mobility that is the norm within the current corporate environment.

Costs of Corporate Membership:

- Annual dues of \$738 per year (split into four quarterly payments of \$170.75) which include:
 - Weekly lunches and Quarterly Dues to Rotary International, Rotary District 6040, Parkville Rotary Club. *Note: Lunches in excess of 1 attendee/week shall be billed separately @ \$12.50/meal.*
 - *Dues are subject to increase/decrease annually.*
- Every Rotarian Every Year (EREY): This initiative encourages all Rotary club members to contribute \$100 every year to help Rotary International reach its goal to support the Rotary Foundation financially each year.
- Other fundraiser participation is highly recommended but is at the discretion of each Rotarian.
- NOTE: Club bills will be addressed to the Corporate Executive Designee and shall be the responsibility of the Corporate Member and not the responsibility of the corporate designees.

Attendance Requirements:

60% attendance is encouraged by Rotary International and all Corporate Members are encouraged to have at least one corporate designee at 60% of the Club's weekly meetings.

Fundraiser Participation:

A Corporate Member's designees shall be considered as one member for fundraiser participation requirements including attendance, sales participation, or buyout.

New Member Induction:

Only the Corporate Executive Designee is required to submit an application for review by the Board. Other corporate designees will not be approved individually but are required to uphold the high standard of ethics of our club members. All designees will be required to attend an informal informational meeting about the Parkville Rotary Club prior to the corporate member being inducted. The Corporate Executive Designee and any willing additional corporate designees shall be inducted into the Parkville Rotary Club after approval by the Board, the club membership, and completing the informal informational meeting.

Rotary International:

The Corporate Member will be represented for purposes of Rotary International and other Rotary Clubs by the Corporate Executive Designee. The Rotary International membership will be held by the Corporate Executive Designee and dues will be paid to Rotary International and District 6040 based on the Corporate Executive. The Corporate Member will only be recognized internally by the Club until such time that Rotary International gives clear guidance as to how Corporate Members should be handled by Clubs.

Club Participation:

A Corporate Member may name five people as his/her designees, of which one shall be designated as Corporate Executive Designee. All corporate designees are eligible to serve on Club Committees. Only the Corporate Executive Designee is eligible to serve on the Board as a Club Officer. The other corporate designees are encouraged to pursue a personal membership if they desire to serve on the Board. A Corporate Member may have one vote for club elections and voting. Unless otherwise indicated by Corporate Member, the Corporate Executive Designee shall vote on behalf of the Corporate Member.
