

HUMAN

What it is and what San Diego is doing about it.



Mary-Ellen Barrett has been a San Diego County Deputy District Attorney for 29 years prosecuting a variety of cases from theft to murder. Ms. Barrett currently handles all petitions for erasing the records of human trafficking victims and reviews all claims of the human trafficking affirmative defense. She is the Human Trafficking Team Leader in her office's Sex Crimes and Human Trafficking Division and is also assigned to the San Diego Trafficking Prevention Collective, a comprehensive anti-human trafficking educational program for students.

Ms. Barrett presents on the issue of Human Trafficking to civic and community groups, both nationally and internationally. She also presents to law enforcement and fellow prosecutors. Ms. Barrett is chair of the San Diego County Regional Human Trafficking and CSEC Advisory Council which is responsible for developing best practice protocols to effectively combat Human Trafficking. Ms. Barrett has previously received the statewide prosecutor of the year award from the California Narcotics Officers Association. She has also received an "Angel of Trafficking Award" by the Bilateral Safety Corridor Coalition, a group dedicated to ending Human Trafficking.

THE SPEAKER

Marni von Wilpert, a Deputy City Attorney at the San Diego City Attorney's Office, was the speaker. She spoke about the opioid epidemic and what it was doing not only to the City of San Diego, but in California, the US and the world. She specifically talked about prescription opioids and the civil lawsuit against Purdue Pharmaceuticals, which is wholly owned by a family trust. She stated that drug overdose is the leading cause of deaths for people under the age of fifty. She showed how there was a direct correlation between the number of opioids sold and the number of deaths. She stated that they were going after opioid producers, not for producing opioids, but because of fraud by the producers. Faux painkiller foundations being set up for promoting the sale of opioids were now declaring bankruptcy.
