## CITY OF SAN DIEGO V. PERDUE PHARMA

Combating the Opioid Industry's Fraud at the San Diego City Attorney's Office

**Marni von Wilpert** is a Deputy City Attorney at the San Diego City Attorney's Office. She represents the City and people of San Diego in Court, enforcing laws that protect consumers, employees, and the environment. She initiates legal action to protect public health and safety, restore environmental quality, and sustain economic vitality in San Diego. When existing laws fall short, Marni advocates for change in City Council.

A San Diego native, **Marni** is a graduate of Scripps Ranch High School and U.C. Berkeley. After college, she served in the Peace Corps in Botswana, providing care and life-sustaining help to children who were born with HIV. She graduated from Fordham Law School, and then founded a free legal clinic in Mississippi to help low-income individuals gain access to the courtroom. Marni then worked in enforcement litigation at the National Labor Relations Board in Washington, D.C., and spent a year improving on education and workforce policy in the United States House of Representatives for Congressman Bobby Scott.

*Now back home in her hometown, she serves on the Boards of several organizations, including San Diego Youth Services, the American Constitution Society, and the National Women's Political caucus.*

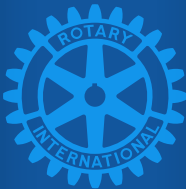

### Steven A. Balch, M.D.

A third-generation Californian, I was born and raised in Los Angeles in a typical 1950's "Leave It To Beaver" family, living in the same happy home until college. I graduated from the Jesuits' Loyola High School (including 3 years of Greek and 4 of Latin). I then attended liberal-arts Pomona College, where

*I met and dated my future wife, Marcia — although we didn't marry until 45 years after graduation!*

Medical school was in hot and humid Houston, Texas (Baylor). Then I spent 8 years of active duty in the Naval Medical Corps, including two West Pac tours in Viet Nam. I next completed my residency in pediatrics at Naval Hospital here in San Diego and practiced there until my Navy retirement in 1973.

At that time, I made one of the best professional decisions of my life. Partnering with another Navy doctor, we set up a medical practice in Solana Beach; we were the only pediatric group between La Jolla and Oceanside at that time. We grew fast, adding 3 partners within 7 years; by the time I retired in 2015, we had a total of 13 partners.

Because I had trained for a year in neonatology, in 1974 Children's Hospital (now Rady's) hired me as a one-year moonlighter in their new NICU. I also attended at NICUs at Sharp Mary Birch, Scripps La Jolla, and Scripps Encinitas. The intense challenges of neonatology were a welcome contrast to my daily practice, but I finally ended it after 36 years of one-year contracts. I also served on various boards and committees at these hospitals.

Marcia and I collectively claim 7 children and 8 grandchildren, and

revel in their various academic and athletic accomplishments. We love musical concerts and live theater, both attending and occasionally ushering as volunteers. Marcia helps Jay out at the Braille Institute Library every Wednesday and is a board member of our HOA. Together, we enjoyed years of helping Rescue House care for their adoptable cats.

My continuing interest in philately occupies 15—20 hours of my week, working on my own collection of French stamps as well as consulting for a large local stamp dealer.

I have regrets for not discovering Rotary much sooner than I did, which happened when Jacquie Reilly invited me to join. I continue to be impressed by Rotary's size, power, and commitment to bettering the world, as well as our own dynamic membership.
