The 2023 season marks Perry's 13th with the Padres after originally joining the club as associate general counsel in April 2011. In her current role, she oversees the Padres' ballpark operations, business strategy and analytics, legal, finance, government affairs and information technology operations.

Perry has been involved in many large-scale projects for the Padres, including the Padres' development project at Tailgate Park, negotiations with the City of San Diego surrounding the All-Star Game and the management of Petco Park and the sale of the team to the current ownership group in 2012.

Prior to joining the Padres, Perry worked as a corporate attorney for Davis Polk & Wardwell LLP in the Bay Area and Cravath Swaine & Moore LLP in New York, where she focused primarily on corporate finance and general corporate matters. Prior to graduating from law school, Perry was an account management associate at BlackRock, the world's largest asset manager.

A native of San Diego, Perry graduated with honors from Stanford University with a Bachelor of Arts degree in Human Biology. Perry earned her law degree from Columbia University, where she was a James Kent scholar and managing editor of the Columbia Business Law Review. She serves on the board of directors of Make-a-Wish, the California Lawyers Foundation and the Association of Corporate Counsel. Perry and her husband, Adam, live in La Jolla with their two daughters, Adeline and Amelia.

Our presentation was driven by **Cynthia Villis** on 20 Years of Building Peace: Rotary Scholars at the Kroc School of Peace Studies.

Cynthia's presentation was bookended by encouragement to consider serving as club President, as an experience of the heart. Cynthia recently retired from USD, and continues to volunteer at the Kroc school.

Joan Kroc's vision was to teach peace and make peace, with contributions totalling \$85 million towards that end. Various degrees are available in MA, MS, and JD in the areas of peace, social innovation, law, and mediation. Rotary Scholars live on campus, are hosted by Rotarians, make presentations, and complete their degrees in 12 to 24 months.

Steve Brown brought details on the Rotary scholarship program, which has funded 34 scholars from 21 countries. Historically, \$15,000 came from clubs, matched by the district, with the Kroc School adding another \$30,000. Two years ago the district shifted so that clubs need to contribute more. Steve and Cynthia are advocating for the district to revert to the previous funding regime.

Our club is often directly involved with scholars, by hosting, etc. **Antonio** and **Maria Grillo** have sponsored several scholars.

Cynthia then presented results

from a recent survey of past scholars.

Saba Kidane (Eritrea) 2003. Founded Eritrean Satellite TV (ERISAT). Received in Eritrea & worldwide.

Yohane Mosara (Tanzania) 2004. Principal Judge, East African Court of Justice.

Ali Hersi (Tanzania) 2006. Manages relief programs.

Qiuwan Zhao (China) 2009. Raised \$1.5M in donations. Direct service to groups of 100 people.

Alex Ouma (Uganda) 2011. Working on World Bank funding program for \$22M in several countries.

Jean Mendieta (Mexico) 2014. Co-Founder of Acto Creativo: Social Transformation Lab.

Naumana Suleman (Pakistan) 2015. Manager of Catholic Commission for Peace.

Veronica Musa (Argentina) 2019. Founder Public Interest and Human Rights.

Nurjamal Shadieva (Kyrgyzstan) 2023 intends to advocate for Uzbeks.

Finally, our current Rotary Scholar **Sharon Mwangi** told us about herself and her goals. Her motivation arises from the post-election violence against women and children that she witnessed in her home country of Kenya. Her goal is to impact African communities in conflict by building inter-agency collaboration to bring peace to Africa.

Jacquie closed our meeting with a selected Maya Angela quote:

In our joy, we think we hear a whisper. At first it is too soft. Then only half heard. We listen carefully as it gathers strength. We hear a sweetness. The word is Peace. It is loud now. It is louder. Louder than the explosion of hombs.


