DSPS is responsible for ensuring the safe and competent practice of licensed professionals in Wisconsin. We administer and enforce laws to assure safe and sanitary conditions in public and private buildings and provide administrative services to the state occupational regulatory authorities responsible for regulation of professional licensing programs. Additionally, with the enactment of 2017 Wisconsin Act 59 all responsibilities and oversight previously charged to the Educational Approval Board transferred to DSPS.

We are also very proud to administer the enhanced Prescription Drug Monitoring Program (ePDMP). The ePDMP is a tool to help combat the ongoing prescription drug abuse epidemic in Wisconsin. By providing valuable information about controlled substance prescriptions that are dispensed in the state, it aids healthcare professionals in their prescribing and dispensing decisions.

Division of Industry Services (DIS)

DIS is divided into two bureaus, an Administrative Services Section, and the Fire Prevention program.

- Bureau of Field Services performs inspections of commercial buildings, amusement rides, boilers, elevators, pressurized gas systems, and mining. The bureau also performs plan reviews of elevators, boilers, and private onsite wastewater treatment systems. The bureau is responsible for auditing third party and municipal inspection agencies.
- Bureau of Technical Services performs commercial building, plumbing, electrical, and fire suppression plan review. The bureau is responsible for administering the Uniform Dwelling Code program, the federal HUD Manufactured Housing program, and provides consultations and training to local building officials, as well as commercial and residential contractors.
- Administrative Services Section provides administrative support to internal and external stakeholders.
- Fire Prevention Program administers the 2% Fire Dues program and provides consultation, support, and training to over 800 fire departments throughout the state.

Division of Professional Credential Processing (DPCP)

DPCP is responsible for all credential application processing, including determination of credential eligibility and renewal. The division is also responsible for licensure, renewal and verification of health, business, trades and manufactured home owners/communities credentials, operation of the department's Customer Service Center and regulation of unarmed combat sports.

Division of Legal Services and Compliance (DLSC)

DLSC provides legal services to professional boards and the department regarding the investigation and discipline of licensed credential holders for violations of professional regulations. The division is also responsible for the complaint intake process, compliance monitoring and a confidential program for impaired professionals. In addition, the Division conducts business compliance inspections and financial audits.

Division of Policy Development (DPD)

DPD is responsible for providing administrative support and policy guidance to the professional boards in the state by facilitating board meetings, serving as a liaison between the boards and the department, and managing the administrative rule promulgation process for self-regulated professions. The division also manages the administrative rule promulgation process for professions and technical programs that are directly regulated by the department. This division is also responsible for continuing education and examination requirements for regulated professions and administration of the Prescription Drug Monitoring Program (PDMP).

Enhanced Prescription Drug Monitoring Program (ePDMP)

The ePDMP is a tool to help combat the ongoing prescription drug abuse epidemic in Wisconsin. By providing valuable information about controlled substance prescriptions that are dispensed in the state, it aids healthcare professionals in their prescribing and dispensing decisions. The ePDMP fosters the ability of pharmacies, healthcare professionals, law enforcement agencies, and public health officials to work together to reduce the misuse, abuse, and diversion of prescribed controlled substance medications.

The ePDMP Statistics Dashboard is a publicly available tool that provides interactive data visualizations about the controlled substance prescriptions dispensed in Wisconsin, the law enforcement reports submitted to the WI ePDMP, and the use of the WI ePDMP by healthcare professionals and others. 

Sophisticated analytics are performed on the WI ePDMP data to alert healthcare professionals to the most relevant patient information.



Top 5 Monitored Prescription Drugs




Buprenorphine HCI-Naloxone HCI Dihydrate

Buprenorphine products are one of three FDA approved medications utilized to treat opioid use disorder as part of Medication-Assisted Treatment (MAT).

Alprazolam (benzodiazepine)

There has been a 47% increase in pharmacy dispensed buprenorphine products in the last three years.




