- A. Paid Applications will be taken in order received. Limit of 50 boats.
  - B. I.G.F.A rules will be followed unless otherwise noted.
  - C. Wire line can be used.
  - D. Only (1) Bluefish and (1) Striper per angler may be weighed in.
  - E. Fish weighed in must be caught the day of the Tournament.
  - F. Fish to be weighed in must be at the scale by 4:00 PM (scale opens at 1 p.m.), July 16, 2022 at the dock of the Wianno Yacht Club.
  - G. "Within Nantucket Sound" Category - fishing limited to "within Nantucket Sound" - only boats less than 26ft in length may choose to fish in this category.
  - H. "Open Category" for Bluefish - no limit to the fishing area
  - I. Striper fishing - no limit to the fishing area
  - J. Boats cannot begin fishing until on or after 6:00 AM on July 16, 2022. Lines out of the water by 2:00 pm
  - K. Channel 78A is the official channel.

- L. Captain's Meeting is 5:30 PM, Friday July 15, 2022 at Osterville Anglers Club. Attendance is mandatory. Osterville Anglers Club 72 Crosby Circle Osterville
- M. In the event of a tie, first fish weighed in is the winner.

**Release and Indemnification Agreement**

I and my team and crew agree and understand that the Osterville Rotary Club and Wianno Yacht Club, its directors, officers, employees and agents (hereafter collectively referred to as ORC/WYC) shall not be liable under any circumstances for any injuries or damages to person or property, arising out of, resulting from or in any way connected with me or my crew's participation in any tournament whether caused by any negligent act or negligent omission of ORC/WYC, or by any other reason or cause whatsoever. In consideration of the acceptance of my and my team and crew's entry and for other good and valuable consideration received, we hereby remise, release and forever discharge ORC/WYC and its respective heirs, executors, administrators, legal representatives, successors and assigns of and from all claims, suits, obligations, liabilities, losses, damages, costs or expenses which our team or our heirs, executors, administrators, legal representatives, successors and assigns may have against ORC/WYC, arising out of, resulting from, or in any way connected with my participation in any Tournament. I understand that this release includes any claims based on any negligent act or negligent omission of ORC/WYC.

To the fullest extent permitted by the law, my team, my crew and I hereby agree to indemnify, to defend with counsel acceptable to ORC/WYC and to hold harmless ORC/WYC, from and against any and all claims, suits, obligations, liabilities, losses, damages, costs or expenses including but not limited to reasonable attorney fees, suffered by ORC/WYC or by any other person or persons, whatsoever, arising out of, resulting from or in any way connected with my participation in any tournament including any and all claims, suits, obligations, liabilities, losses, damages, costs or expenses caused in whole or in part by any negligent act or negligent omission of ORC/WYC or anyone for whose acts ORC/WYC may be liable regardless of whether it is caused in part by a party indemnified hereunder.

**ADDITIONAL INFORMATION:**

The Rotary Club of Osterville Annual Bluefish Tournament was conceived with the purpose of raising funds for the benefit of over 50 charitable and civic organizations within Barnstable County; to name a few:

- Big Brothers/ Big Sisters
- Cape Cod: Community College, Child Development, Hospital, Symphony, YMCA
- YMCA Cape Cod

- Barnstable Senior Center

The event will take place on Saturday July 16, 2022. There is a maximum of 50 Boats who can compete for 3 first prizes of \$750, and a Buoy Prize of \$250 plus additional prizes and plaques. The Tournament's crystal trophy with the winners' names permanently engraved, is housed at the Osterville Anglers Club and displayed at various other public places during the year.

The July 13th event takes place at the Wianno Yacht Club, Bridge Street, Osterville. The Captains must be at the **Captains meeting the night before – Friday, July 15, 2022 at 5:30pm at the Osterville Anglers Club, 72 Crosby Circle in Osterville.** Anglers can begin fishing within the tournament area after 6:00 a.m. on July 16, 2022. Anglers will weigh in only one fish in each category and present it for weighing by 2:00 p.m., from their registered boat at the Wianno Yacht Club pier.

There will be 2 Bluefish categories and 1 Striped Bass category. For the Bluefish Prizes we will have 2 categories. The first category is "Within Nantucket Sound" - for boats less than 26'. **Only boats less than 26' may choose to fish in this category.** The fishing area will be limited to "within Nantucket Sound."

The second category is "Open Category" and you will be allowed to fish anywhere that you would like. If your boat is 26' or over, this is the category that you will be fishing in. **If your boat is less than 26' you may fish in this category - you have to make this decision on the night of the Captains meeting.**

The third category is for the heaviest Striper. Make sure that you follow the state rules for catching Stripers. We will have the Tournament monitoring a preselected channel and reporting results throughout the day.

We will also have Juniors Division for those anglers under 15 years old. We will have trophies for 1st and 2nd heaviest fish in this category.

Winners will be announced, and prizes awarded under the tent during the Bar-B-Que Party to which the entire family is invited at an additional cost of **\$20 each, \$7 for children.** (The Bar-B-Que is included for all Anglers registered for the Tournament.) An auction, along with a raffle, will present an opportunity for everyone to have fun, socialize, and bring home some great bargains.

To participate, use the attached application, or pick up one at your local bait shop or from Kevin Pepe, 222 West Main St, Hyannis, MA, (508) 962-5022. The entry fee will be \$200 per boat. This includes 2 Anglers. Additional Anglers will be charged \$50 each.

**All qualified fish must be weighed in on the official scale, at the Wianno Yacht Club dock, from a registered boat!**
