### Project Narrative

1. Briefly describe the project.

a. What were your original objectives?

This project will provide safe drinking water by construct 4 drinking water systems, 30 units of toilet in 4 schools and 2 hostels of Chiang Mai, Chiang Rai and Mae Hong Son provinces in northern part of Thailand. This will improve the health conditions and sanitation of 1,000 students.

b. What was actually accomplished? (Photographs can help to tell your story. Please submit any action photos that you have that show beneficiary participation and demonstrate Rotarian involvement in the project. Please also indicate the name of the photographer.)

We were able to dig 2 underground water within 2 schools in mountainous and remote areas and digged 3 shallow wells within 1 school located in Mynmar border, built about 20 units of toilet plus 10 units of bath rooms to 5 hill tribe hostels and one school. Provided concentrate training on the topic " Integrated Agricultural and Natural Resources Preservation" to 25 selected or key students from 5 schools during 26 – 28 March 2010 at the Faculty of Animal Science of Chiang Mai University beside of formal training Rotarian members did on training when they visited project sites to teachers, students and their parents about the goal, vision and history of Rotary. (Please see details in the pictures in attached files). 10,000 fingerlings, 40 pigs and 100 black bone chickens were contributed to the beneficiaries plus 300 kg of seasonal vegetable seeds, 3,000 pieces of mushroom and tools for gardening to beneficiaries. The project are not yet completely it has been only 60% work done. We are going to install water filtration within the water tower to the project areas.

c. When and where did the project take place, and who were the beneficiaries?

**There are 5 schools that we implementing the projects.**

1. Piang Lunag school there are about 12,000 students we provided onsite training and digged 3 shallow wells already. This project site we collaborated with Engineer Without Border (EWB) to do data collection, survey and research in terms of water water problem in this area plus collected water from different

sources for testing the quality. (The result of water quality test are available from EWB). The EWB plan to visit again this coming August and will install the filtration system to this project site (the EWB visited 2 times already once in 2009 and another time in March 7-12, 2010).

2. Sanpong School there are about 120 students we provided the underground water to supplies their students plus about 400 villagers whom live surrounded the school can benefits from our water sources.
3. San Klang School there are 220 students in this school we are preparing to install the water filtration system in this school on pretty soon.
4. Maepakee School there are about 240 students in this school we provided the underground water to supplies their students plus about 900 villagers whom live in surrounded there.
5. Suksa Nari Anusorn II school we are able to provided 6 units of toilet and small fish pond with seasonal vegetable seed to 180 students there.

### **The Hill Tribe hostels**

There are 5 hill tribe hostels located in Chiang Mai and Chiang Rai province there are about 250 students benefits from this project sites. We able to provided training and livestock such as pigs, fingerlings, chicks and seasonal vegetable seeds for there to grow for home consumption.

2. Scope change. If the project was changed, how and why was it changed?

The scope was not changed too much but instead of focus the water filtrations system in each project site we have spent budget in provided water sources due to many areas were shortage of water sources. Since this is a large project and implemented with the goal of safe drinking water for many beneficiaries, additional communities were interested in taking part and the Rotary Club of Chiang Mai North collaborated with other Governmental and Non-Governmental organizations such as:

- 1) Community Livelihood and Environmental Development Project
- 2) Chiang Dao Rural Community Development
- 3) Livelihood and Environmental Enhancement
- 4) Local administration departments in each project area
- 5) Veterinary School, Animal Sciences Dept and Faculty of Engineer of Chiang Mai University
- 6) Maekam watershed Development foundation
- 7) Borderless Friendship Foundation
- 8) Engineer Without Border (EWB)
- 9) Case Western University (from USA)

Prior to the safe drinking water sources the Rotary Club of Chiang Mai North worked with local project partners to provide necessary training to the designated beneficiaries on topics such as:

- a) History of Rotary
- b) Concepts of holistic development
- c) Planning Management
- d) Compost Fertilizer, animal Feed
- e) Global warm
- f) Basic Healthcare and sanitation
- g) Maintaining water filtration system

Each school was monitored by a committee from the Rotary Club of Chiang Mai North.

RC of Chiang Mai North set up committees to monitor each project area in collaboration with local project partners. The committees provided support to the project beneficiaries and received support from local related organizations such as educational institutes in order to achieve goals successfully.

The Rotarian members of Twinsburg coordinated partner organization like EWB and Case Western University to close consulted and implement the project in Thailand. visited the project site at Piang Luang School which located in Thai-Myanmar border 2 time already and they will come again in the future, every time when they came they held the meeting with RC of Chiang Mai North members and related local organization such as Faculty of Engineer from Chiang Mai University to discuss and find they way how to solve the water shortage problem in terms of quality and quantity of water in long term period for 1,200 school kids there.

9. What was the impact of the project on the beneficiaries?

Most of the project beneficiaries are living in remote, mountainous areas and are limited by factors such as health care & sanitation and lack of clean & safe drinking water for them many time the water has been shortage. This project brought them new water sources with good quality & quantity and knowledge about how to manage the water in proper way. Also new tools were given to them, such as safe drinking water filtration tanks, vegetable seed, basic livestock for breeding.

Furthermore, they learned how to maximize their local raw materials such as organic vegetables, composted fertilizer, animal production, which increased their income as well as reduced their school expenses. They becoming a model of School other neighbors and schools.

10. What are the expected long-term community impacts of the project?

Project participants (Teachers & students) have the potential and training to solve and manage unexpected challenges by themselves and will be able to mobilize outside resources effectively to help their school.

Project beneficiaries can now pass on their knowledge, skills, and new training to other needy school and people on such topics as how to maintain the water filtration system, grow seasonal vegetable and basic animal raising and breeding.
