**ROTARY CLUB OF MASSILLON  
BOARD OF DIRECTORS MEETING MINUTES  
JUNE 6, 2023**

The Board of Directors met at Kozmo's Grille on Tuesday, June 6, 2023. The following members were present: Dan Swartz, Tom Jingo, Jim Stanford, Keith Nutter, Dick Leffler, Angela Cooper, Carolyn Worthen, Dr. Bill Leffler, and Chad Hartman.

The minutes of the May 1, 2023 Board meeting were presented for approval. Upon a motion by Mrs. Cooper and a second by Mr. Stanford, the Board approved the minutes, as presented.

**SECRETARY'S REPORT:**

Mr. Jingo presented a notice of resignation from Sherie Brown. Mrs. Brown recently retired as Director of the Massillon Public Library. Upon a motion by Mr. Jingo and a second by Mr. Nutter, the Board accepted Mrs. Brown's resignation, with regret.

**TREASURER'S REPORT:**

Mr. Leffler distributed the current Accounts Aging Report. He asked the Board to consider cancelling a former member's account for an overpayment of \$44. Upon a motion by Mr. Nutter and a second by Mr. Stanford, the Board approved Mr. Leffler's request.

**CLUB SERVICE:**

Mr. Hartman reported that the club's participation in the IMPACT Massillon Project was quite successful, with a good turnout of volunteers and the fact that the painting of a house went well. He advised the Board that the actual cost of the project had exceeded the \$500 budget by \$517.50. Upon a motion by Mr. Leffler and a second by Mr. Nutter, the Board voted to approve the additional \$517.50 cost for this project. Mr. Hartman has, also, been able to secure commitments from two additional volunteers for Meals-On-Wheels.

**MASSILLON ROTARY FOUNDATION:**

President Swartz reported that the Foundation's request to the City of Massillon for the return of a \$50,000 for a project that will not be undertaken, has not yet fulfilled.

**PROGRAMS:**

On June 22<sup>nd</sup>, rather having a program, we will have a club business meeting. That meeting will serve to update the club membership on current and recent projects and to discuss some operating changes that have been proposed.

**PRESIDENT'S REPORT:**

The Board discussed reasons why some scholarship recipients fail to apply for the second payment of \$500. One suggestion was to pay the full \$1,000 initially.

The Board reviewed our club's relationship with the Paul Brown Scholarship Committee. If we decide to sever that relationship, we should probably first have an attorney review the agreement to clarify our legal responsibilities in this matter.

The meeting for the preparation of the 2023-2024 club budget is scheduled for June 20<sup>th</sup>, at 4pm, at Dick Leffler's office. All members are free to attend and committee chairpersons are urged to attend, with recommendations for the budgetary needs for their area of responsibility.

Since no one has accepted the nomination for 2023-2024 President-Elect, the Board nominated Mr. Swartz to serve a second term as Club President and Mr. Stanford to serve a second term as President-Elect. Those nominations will be presented to the club membership at the June 22<sup>nd</sup> club business meeting.

Mrs. Cooper volunteered to form a committee to review and recommend updates to the club's by-laws.

**NEXT MEETING:**

The next regularly scheduled meeting of the Board of Directors is August 1<sup>st</sup>, at 11:30am, at Kozmo's Grille.

**ADJOURNMENT:**

Upon a motion by Mr. Hartman and a second by Mr. Nutter, the meeting was adjourned at 1:00pm.
