BOARD OF DIRECTORS MEETING MINUTES
November 3, 2020**

The Board of Directors met at Kozmo's Grille on Tuesday, November 3, 2020. The following members were present: Bill Leffler, Matt Hull, Richard Regula, Todd Loxley, Daniel Swartz, Richard Leffler, Kathy Schultz, Michelle Hartman and Keith Nutter. Also present was Jay Bomze.

The first matter of business was to approve the minutes of the October 6, 2020 meeting. Upon motion duly made, seconded and unanimously carried the minutes of the October 6, 2020 meeting were approved.

SECRETARY'S REPORT:

Mr. Hull presented to the Board the proposal to accept the admission of Mr. Jeff Brest as a member of the Club. Upon motion duly made, seconded and unanimously carried the Board voted to approve the admission of Mr. Brest.

Mr. Hull also notified the Board that Adrienne Price has asked that her membership be converted to a corporate membership for the United Way. This would allow more participation from individuals at the United Way to attend meetings when Adrienne is unavailable to attend.

The Massillon Museum was approved as a member in March, however, they still need to be inducted at a Club meeting and Mr. Jingo will need to order a badge for the Museum.

TREASURER'S REPORT:

Mr. Leffler led a discussion regarding the special meeting of the Board to approve the individuals authorized to sign checks on the Club's behalf. Out of an abundance of caution, Mr. Leffler suggested simply approving the authorized individuals through a motion and vote at the current meeting. Upon motion duly made, seconded and unanimously carried the Board voted to approve Kathy Shultz, Matt Hull and Keith Nutter to replace the 3 current signers on the First Commonwealth account.

CLUB SERVICE:

Mr. Hull presented for discussion the fact that someone needs to replace Lori as the Club's RYLA coordinator to work with the schools and identify students who would like to participate in the RYLA leadership conference. Mr. Bomze stated he would be happy to do this and Mrs. Hartman expressed she would assist him if needed.

Mr. Bomze stated that students of the month from Massillon High School would again be attending Club meetings but that Tuslaw was still prohibiting such student travel. Mr. Hull stated he had reached out to Fairless to see if they would like to participate and is waiting to hear back.

Mr. Hull presented for discussion the idea that the Club engage in a general fundraiser by selling support local cards with various discounts offered by local businesses. Mrs. Hartman stated she would look into getting the cards made and the Board would need to undertake efforts to seek out businesses who would be willing to participate.

Mr. Hull also presented for discussion the fact that the Purple Bag Project was gearing up for 2021 and would be asking local Rotary clubs to pick a month in which they would fill purple bags with items for victims of domestic violence. Mrs. Hartman stated she would reach out to Joy Dougan to coordinate this with our Club.

Finally, Mr. Hull presented for discussion the 2020-2021 Four Way Test Speech competition and the need for a Club member to coordinate with the schools to see if any students would like to participate. Mr. Bomze stated he would coordinate this with the schools and Mrs. Hartman stated she would assist if needed.

Mr. Hull and Mr. Bomze discussed the pick 3 fundraiser and using the fundraiser to support the SAM Center since the Club was unable to do so due to cancelling the annual fundraiser. Mr. Bomze stated he would assist in getting the tickets printed and distributed to the members and Mr. Hull stated he would have Krugliak, Wilkins, Griffiths & Dougherty cover the costs of printing and distribution so that there would be no costs to the Club. Each Club member will be responsible for selling 20 tickets at \$5 each. The drawing will be held each day in the month of January.

The Board briefly discussed the social Dan McMasters had agreed to host and the money the Club gave to Mr. McMasters for the social. Mr. Hull stated he would follow up with Mr. McMasters to see if he would return the \$200 the Club gave him for the social. In the event Mr. McMasters would hold a social in the future the Club could send him the money again.

Mr. Hull gave the Board a brief update on the potential Tuscarawas River clean-up project. The group discussing the project is to have another meeting on Friday November 6th.

NEW BUSINESS:

The Board briefly discussed the need to cancel, alter or postpone Club meetings due to the COVID-19 pandemic. The Board decided to not take any action at this time.

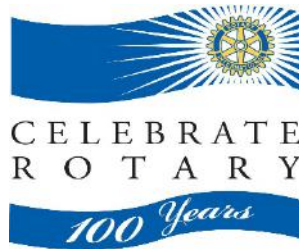
