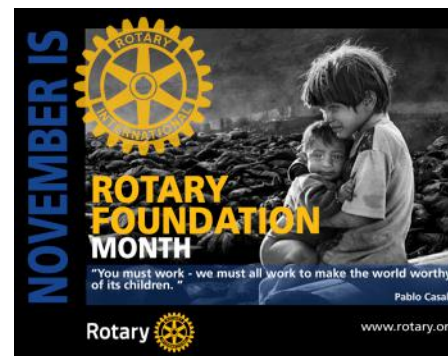

The minutes of the August 3, 2021 Board meeting were presented for approval. Upon a motion by Mr. Swartz and a second by Mr. Logan, the minutes were approved, as presented.

SECRETARY'S REPORT:

Mr. Jingo presented the membership application of Andrea Scassa. She is the Magistrate of the Massillon Municipal Court. Her sponsor is Kathy Shultz. Upon a motion by Dr. Leffler and a second by Mrs. Shultz, the Board approved Andrea Scassa membership application for presentation to the club membership.

The average percentage of active member attendance at the August club meetings was 46.71%.

The Board asked Mr. Jingo to prepare a list of low-attendance members so that they might be contacted and encouraged to resume regular attendance at club meetings.

TREASURER'S REPORT:

Mrs. Hartman reported that the Purple Bags had been delivered. The date for the Habitat for Humanity service project in Massillon is October 23rd. We will need at least 4 to 6 volunteers in order to participate. Our Coats for Kids project is underway. President Hartman has recruited Shane Craney to organize and lead the Rotary Corps unit.

Mrs. Shultz reported that she is working on several prospective new member leads.

MASSILLON ROTARY FOUNDATION:

The next Foundation Board meeting is scheduled for September 9th. Mr. Logan indicated that the Board is currently accepting grant requests.

PROGRAMS:

Mr. Swartz apprised the Board that all September club meeting dates have program scheduled. He also reported that he is exploring ideas for the club's main fund-raising project and asked Board members to share their ideas with him.

PRESIDENT'S REPORT:

We will need someone to coordinate the Student of the Month program, as soon as the schools are ready to resume.

President Hartman proposed that the Board appoint Jeff Brest and Carolyn Worthen to fill two of the three vacant Directors positions for the Class of 2020-2023. Upon a motion by Mrs. Shultz and a second by Mr. Logan, the Board approved the appointment of Jeff Brest. Upon a motion by Mr. Jingo and a second by Mr. Leffler, the Board approved the appointment of Carolyn Worthen.

The next regularly scheduled meeting of the Board of Directors is Tuesday, October 5th, at 11:30am, at Kozmo's Grille.

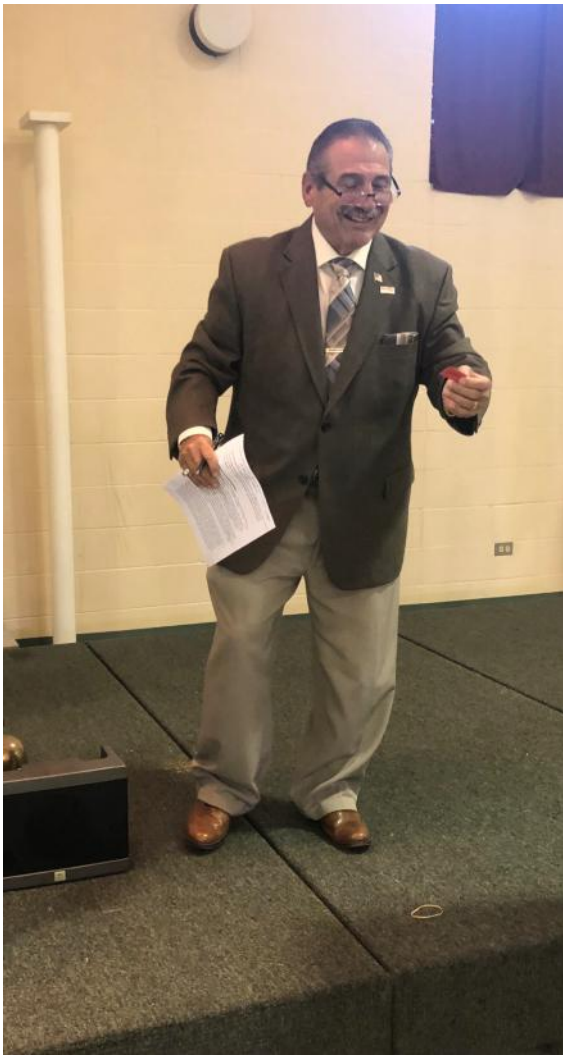
