

### ROTARY CLUB OF MASSILLON BOARD OF DIRECTORS MEETING MINUTES September 1, 2020

The Board of Directors met at Kozmo's Grille on Tuesday, September 1, 2020. The following members were present: Bill Leffler, Matt Hull, Richard Regula, Todd Loxley, Chad Hartman, Daniel Swartz and Richard Leffler.

The first matter of business was to approve the minutes of the August 5, 2020 meeting. Upon motion duly made, seconded and unanimously carried the minutes of the August 5, 2020 meeting were approved.

### SECRETARY'S REPORT:

Mr. Hull presented to the Board the proposal to add Daniel Swartz as a member of the Board of Directors. Upon motion duly made, seconded and unanimously carried the Board voted to add Mr. Swartz as a member.

### TREASURER'S REPORT:

Mr. Leffler reported that the overall cash position of the Club was in good shape and that the quarterly dues have been sent out. Mr. Leffler also discussed setting a date and time to review the proposed Club operating budget for 2020-2021. Once determined, this date and time will be sent to all Board members to participate in the discussion of the budget with Mr. Leffler and Mr. Hull.

Mr. Leffler also presented to the Board a request by CommQuest Services for a donation from the Club in the amount of \$600 in order for the Club to sponsor a room and help support the Family Living Center. Upon motion duly made, seconded and unanimously carried the Board voted to approve a donation to CommQuest Services in the amount of \$600.

### **CLUB SERVICE:**

The Board discussed the Club's participation in Operation Warm again this year. Both the Salvation Army and the Boys and Girls Club have ordered coats. Club Members can purchase coats and have the amounts added to their bill. Mr. Hull stated he would continue to pass the sign up sheet around at the meetings and would additionally send an email to all Club Members.

Mr. Hull also presented to the Board a potential project involving cleaning tires out of the Tuscarawas River. Mr. Hull and Mr. Swartz will be meeting with Judge Elum and others to discuss this project.

### INTERNATIONAL:

Mr. Leffler reported that the Club will be providing \$1,000 to the Shelter Box program this year. A representative from the project will be speaking at an upcoming meeting to give us an insight on how our support impacts the program.

### **PROGRAMS:**

Mr. Hartman gave an update on the upcoming programs. It was also presented for discussion whether the annual fundraiser, currently pushed back to February, would likely go forward. Mr. Hull stated that unless the circumstances surrounding COVID 19 dramatically change in the next few months we will likely be discussing pushing the fundraiser back again, at which point the Board may want to consider alternate ways to raise funds.

Mr. Hartman stated that the joint meeting with the Canton Rotary Club appears to be moving forward and that the Canton Club was waiting to receive final approval from their board. Bob Cummings will be the featured speaker for the meeting, which will not have any players, cheerleaders or band members.

Mr. Hartman further presented to the Board that the fifth Thursday social on October 29<sup>th</sup> is currently scheduled for Dragon Fly Winery. Mr. Hartman also mentioned inviting the Canal Fulton Rotary Club to join us at this social.

### OLD BUSINESS:

The Board discussed the status of the Rotary Pavilion Project of which Mrs. Litman had been keeping the Board apprised. Mr. Hull stated he had followed up with Mrs. Litman to see if she would still like to be involved in that project but had not heard back. The Board discussed the Paul Brown Scholarship and the scholarship committee and the desire to hold an annual event for the recognition of the scholarship award as has been done in prior years. Mr. Swartz indicated he would get involved again to run the committee if the committee approved.

### **NEW BUSINESS:**

Mr. Hull presented to the Board a request to sponsor Richard Regula in the upcoming century ride to benefit the Tow Path Trail. Upon motion duly made, seconded and unanimously carried the Board voted to approve a donation to in the amount of \$200 to sponsor Mr. Regula.

The next regularly scheduled meeting on the Board of Directors is Tuesday, September 6<sup>th</sup>, at 11:30am, at Kozmo's Grille.






